Course Description

3 hours. Introduces fundamental concepts, practices, procedures, processes, and vocabulary for the entire curation lifecycle of digital materials and data, from creation through appraisal, ingest, and storage, to access and reuse. Covers history and background; concepts and principles; community standards and practices; challenges and issues; and basic techniques for curating and managing digital materials and data.

Course Pre-requisites

None.

Course Requirements

This course is organized into 9 learning modules, each lasting a week or two.

Course Delivery Format

Although the majority of the course is delivered in an asynchronous format (meaning there is no set time that you must be logged into the online course), this course does contain optional synchronous meetings that will give students a chance to interact with their instructor/classmates and ask questions in real time.

LEARNING OUTCOMES

By the end of the course, students should be able to:

- Define terminology commonly used in digital curation
- Establish a broad context for the issues and challenges facing digital curation and data management
- Articulate major concepts for framing digital curation
- Explain stages and activities required for digital curation
- Interpret and apply standards for digital curation and data management
- Understand existing technologies and applications used ion creation, documentation, management, and preservation of data

REQUIRED MATERIALS

There is no required textbook.

However, each module has required readings that are listed in the "Reading" section of the modules. Use of the UNT library electronic resources may be necessary because some readings can be retrieved electronically.

ASSIGNMENTS

Module Assignments (78 points)

Each module has one or two assignments, which may consist of reviews, quizzes, and/or hands-on exercises. Note that each module has a single deadline for completion of all required assignments as it runs through a week or two weeks.

Final Paper (22 points)

Students will develop a short position paper (at least 1,500 words) about controversial issues and challenges related to digital curation.

COURSE POLICY

Late Work

All students are expected to submit their module assignments and final assignment by the due date. This prevents students from getting too far behind in the course and allows the instructor to assign grades in a consistent manner.

All students who do not complete their module assignments by 11:59 PM Central Time on Sunday will be penalized 15% of the module assignments for each date late unless there are extenuating circumstances. The final paper received after the due date will incur a 1-point deduction penalty for each day late unless there are extenuating circumstances.

Important Notice for F-1 Students taking Distance Education Courses Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G). The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
