## Course Description (from UNT catalog)

This course extends the concepts developed in Data Analytics I to multivariate and unstructured data analysis. Modern multivariate analysis techniques, including association rules, classification methods, time series, text analysis, and machine learning methods, are explored and implemented with real-world business and industry data. The course will provide a hands-on introduction to state-of-practice technology and tools. The course focuses on the application and interpretation of the methods discussed.

- Understand and apply a variety of multivariate data analysis techniques.
- Use Python for various purposes
- Apply advanced data visualization and dimension reduction techniques.
- Understand and apply techniques for performance evaluation.

- Apply k-Nearest Neighbors (k-NN).
- Use classification and decision trees.
- Facilitate neural nets and cluster analysis.
- Apply concepts learned in course to real world case studies.

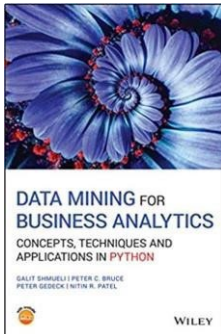
### Course Structure

The course, split into 9 modules, is an in-person 16-week format. ### Discussion Posts (10% of overall grade)

There will be four discussion posts of equal weight. They are designed for you to share your thoughts and experiences related to the discussion topic. To earn full points on discussion boards, students must be actively engaged and provide input to each question. Your responses are expected to be thoughtful, respectful, and grammatically correct, revealing your understanding of the discussed topic. The use of generative AI tools is strictly forbidden.

### Assessment Assignments (30% of overall grade)

There will be eight assessment assignments throughout the semester that are related to the materials covered in the modules. You will gain hands-on experience in conducting statistical analyses, usually using the software. Assignments may include questions to be answered about a specific concept, analysis using provided data sets, use of Python coding for analysis, interpretation of the results, questions directly/indirectly related to the course material, or else. Written responses are expected to be free of spelling/grammatical/typo errors. Use of generative AI tools is strictly forbidden.

### Final Project (30% of overall grade)

The final project will give you independent applied research experience by using real data and statistical methods. You will complete the semester-long project in a team of up to four students. You will be asked to acquire a data set of sufficient size to complete your analysis. Your project will have a purpose and a story behind that purpose. It will have solid implications underlined in your final report. You will make use of data analytics to come up with a proper solution to a problem or an answer to a question with appropriate tools. The use of generative AI tools is strictly forbidden.

**Project Group Members Selection (1% of overall grade):** You will select group members to work with. The maximum group size is three.

**Project Proposal and Data Set (3% of overall grade):** You will propose a project and submit your data set. Your project will have a purpose. It may be after finding an answer to a major question or solving a business problem, but it should not be purposeless (just

applying things you learn in the course). You can submit the link to the data set, but you must be specific in the variables you use, especially the target variable.

**Python Codes and Outputs (5% of overall grade):** You will submit the Python codes you use to get your analytic results with their outputs. Codes should be ready to run again in a Jupyter Notebook, and the final version of the data sets used. Comments to highlight your Python commands should be included in code blocks.

**PowerPoint Slides and Recorded Presentation (7% of overall grade):** Prepare 10-15 slides introducing your project, explaining your methodology, key findings of your statistical analysis, and recommendation(s) about what action should be taken based on your findings. You will then record your presentation, which will last about 10 minutes. All members of the group are expected to participate in the recorded presentation. The presentation will be intended for the audience who are not interested in the technical aspect of the analysis but the main advantages of it.

**Project Report (9% of overall grade):** Write about a 5000-word project report outlining the methodology and key findings of your statistical analysis as well as suggestions for how your intended audience should make use of your findings. Your project report should include the title, abstract, and names of all group members on the front page, as well as the table of contents and bibliography. Your project report should include 4-6 charts.

**Feedback on your team member (optional; submit if you think it is necessary):** You will submit if you think a group member did not contribute sufficiently. If the majority of the group members indicate that a specific group member did not contribute sufficiently, I will grade that group member's final project accordingly.

### **Final Exam (20% of overall grade)**

The final exam will be open notes and comprehensive.

### Important Notice for F-1 Students taking Distance Education Courses

**Federal Regulation** To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses please go to the Electronic Code of Federal Regulations website (<http://www.ecfr.gov/>). The paragraph reads:

### University of North Texas Compliance

### Transmission and Recording of Student Images in Electronically Delivered Courses

3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may be reused in future course offerings.
