## COURSE PHILOSOPHY/OBJECTIVES

In this course, we aim to develop and refine the practical skills most commonly expected of a modern-day jazz pianist, including (but not limited to):

- transposition and quick functional analysis of a tune
- spontaneous arranging: creation of clear introductions, interludes, and "outros"
- left hand accompaniment styles, including functional basslines, variations of comping rhythm,
- 2 note "shell" voicings," simple stride patterns, rootless 3 and 4 note voicings, and more
- two-handed accompaniment styles, including 3, 4, 5 and 6 note standard voicing structures, upper structures, "So What" style voicings, florid comping styles, basic montuno figures, and more
- functional coordination and interdependence of the left and right hands
- general procedures of ensemble playing, including accompanying vocalists
- sight-reading lead sheets and written-out material

This course sequence helps the student master the foundational skills needed to secure *work and employment* as a professional jazz or contemporary pianist. In addition, it gives students a firm basis with which they can pursue their unique artistic visions and aesthetic agendas in the later years of their degree program.

The instructor(s) may cover additional topics according to specific student abilities and needs, including but not limited to:

- transcription strategies and specific analysis of famous jazz piano solos
- deeper stylistic/comparative analysis of jazz piano styles and textures
- advanced chord substitution and reharmonization techniques
- advanced rhythmic training and hand coordination study
- contrapuntal improvisation and other modern techniques

# **COURSE CONTENT/MATERIALS**

There is no textbook required for this course, but students should be able to seek out recordings and lead sheets.

## **COURSE POLICIES AND INFORMATION**

**GRADING:** Your grade is determined by the following criteria.

50%: 6 Performances (lowest dropped) 30%: 6 Sight-reading assignments 10%: 1 Transcription Assignment 10%: Final Sight-reading Exam

The final grade is determined by the following scale:

A = 90-100%, B = 80-89%, C = 70-79%, D = 60-69%, F = below 60%.

\*\*Grades that are one point or less below a cutoff can be rounded up at the sole discretion of the instructor based on a student's overall effort, disposition, and attendance both in class and in office hours. For example, 89.1 and 89.0 *can* be rounded at the instructor's discretion, 88.9 *cannot*.

### **ATTENDANCE:**

Please note: Attendance is not directly factored into any of these grading criteria, but each unexcused absence **after the THIRD** will lower your **final grade** by 5%, regardless of performance in any of the above criteria. This is a generous attendance policy that allows you to miss approximately 10% of class meetings with no questions asked. After your third absence, the policy is strictly enforced.

Excused absences are, of course, always permitted with reasonable cause and ample notice (when possible). **These absences do not count towards the three unexcused absences**. Please email the instructor to clear these in advance, or as soon as possible after-the-fact in case of emergency. Please provide documentation/verification.

If you feel overwhelmed in any way, or if you are dealing with something that is causing you to miss a significant amount of class, the best thing to do is speak with the instructor as soon as possible. Do not wait until the end of the semester when grades are published.

## <u>Undergraduates</u>

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course being doing so.

### Graduates

Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program.
