**No, but they are the same course.** The lecture and the lab are separate classes, each with a unique professor/TA, meeting time, and location. See your lecture professor for lecture information.

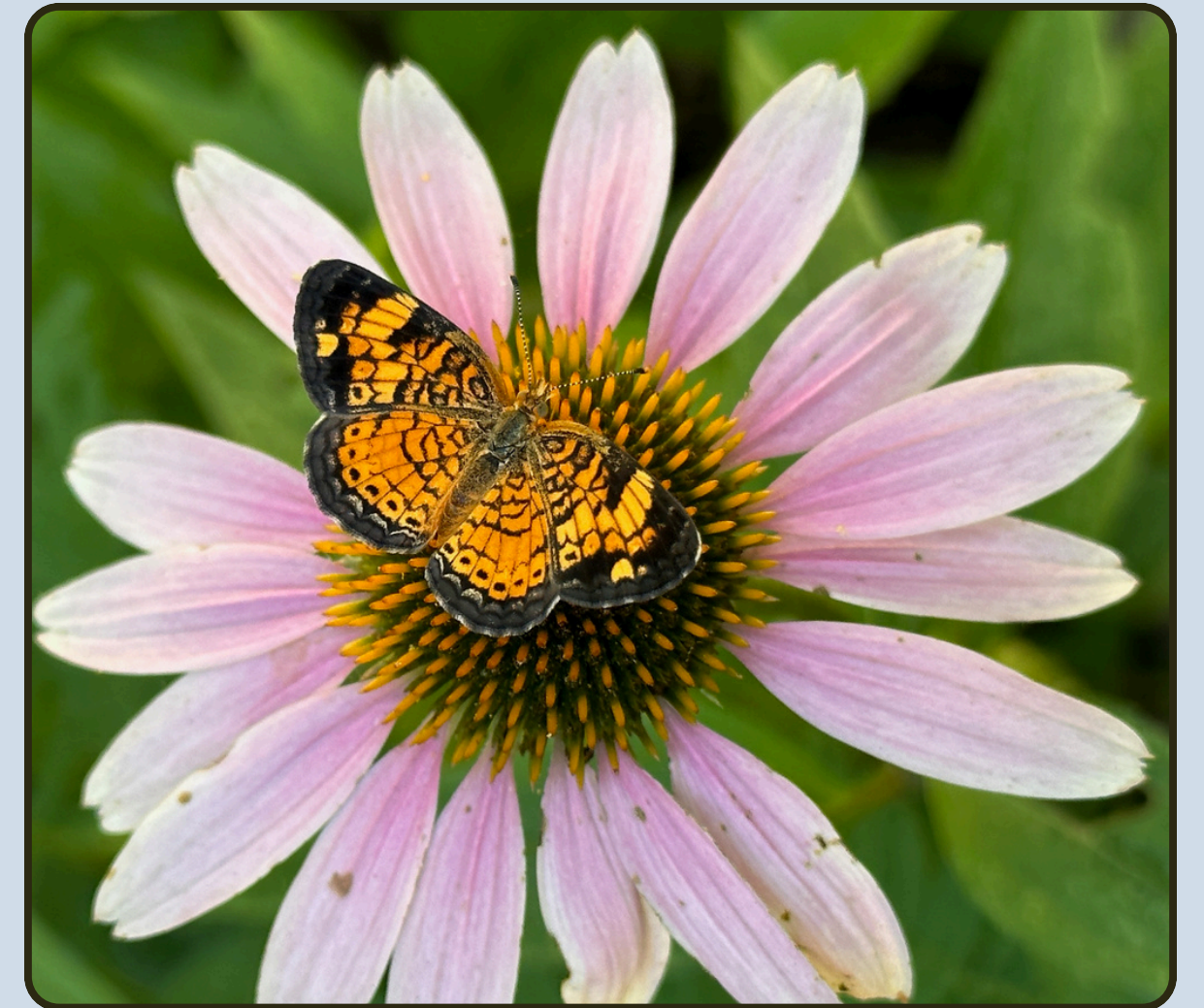
## 2) Is lab attendance mandatory?

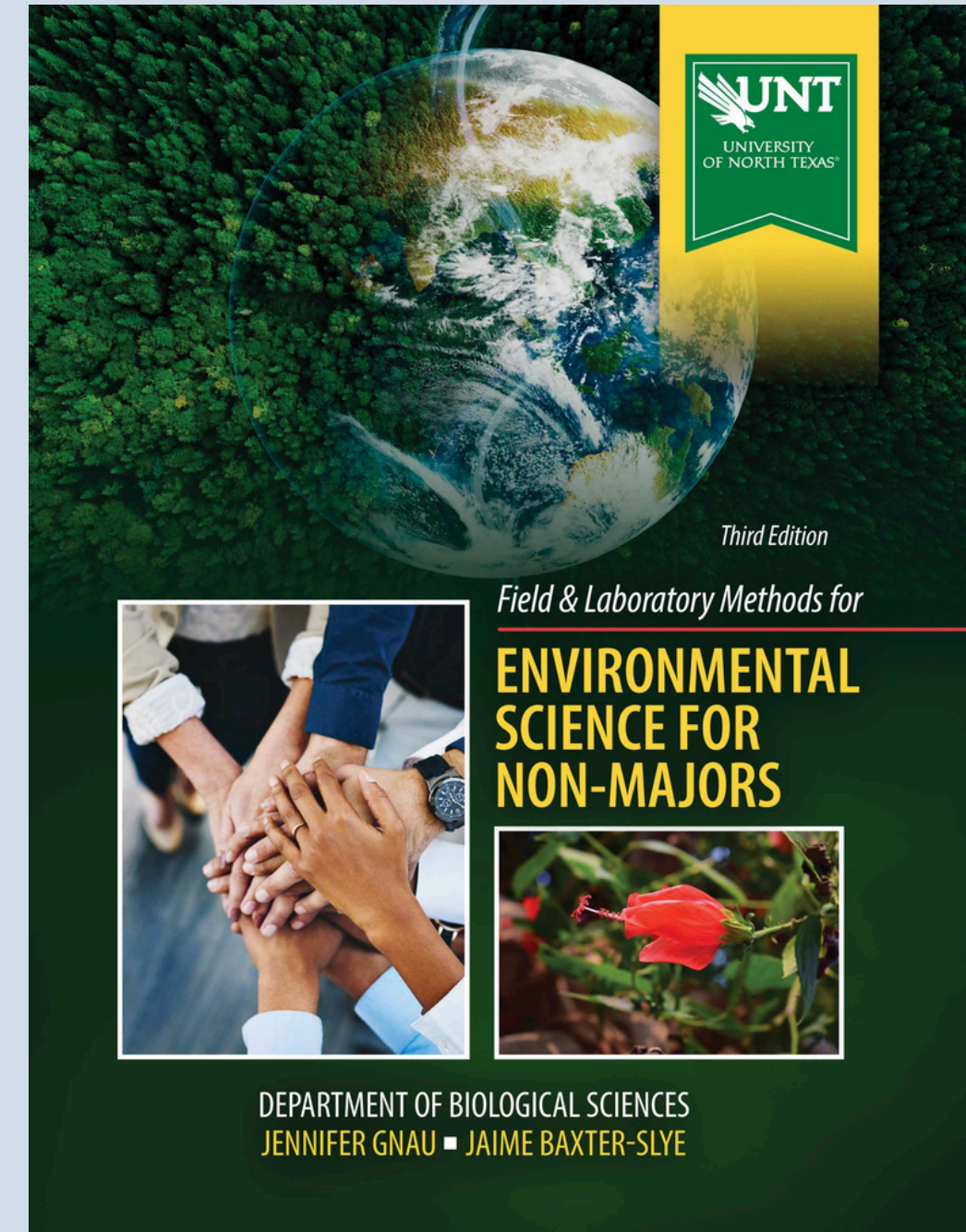

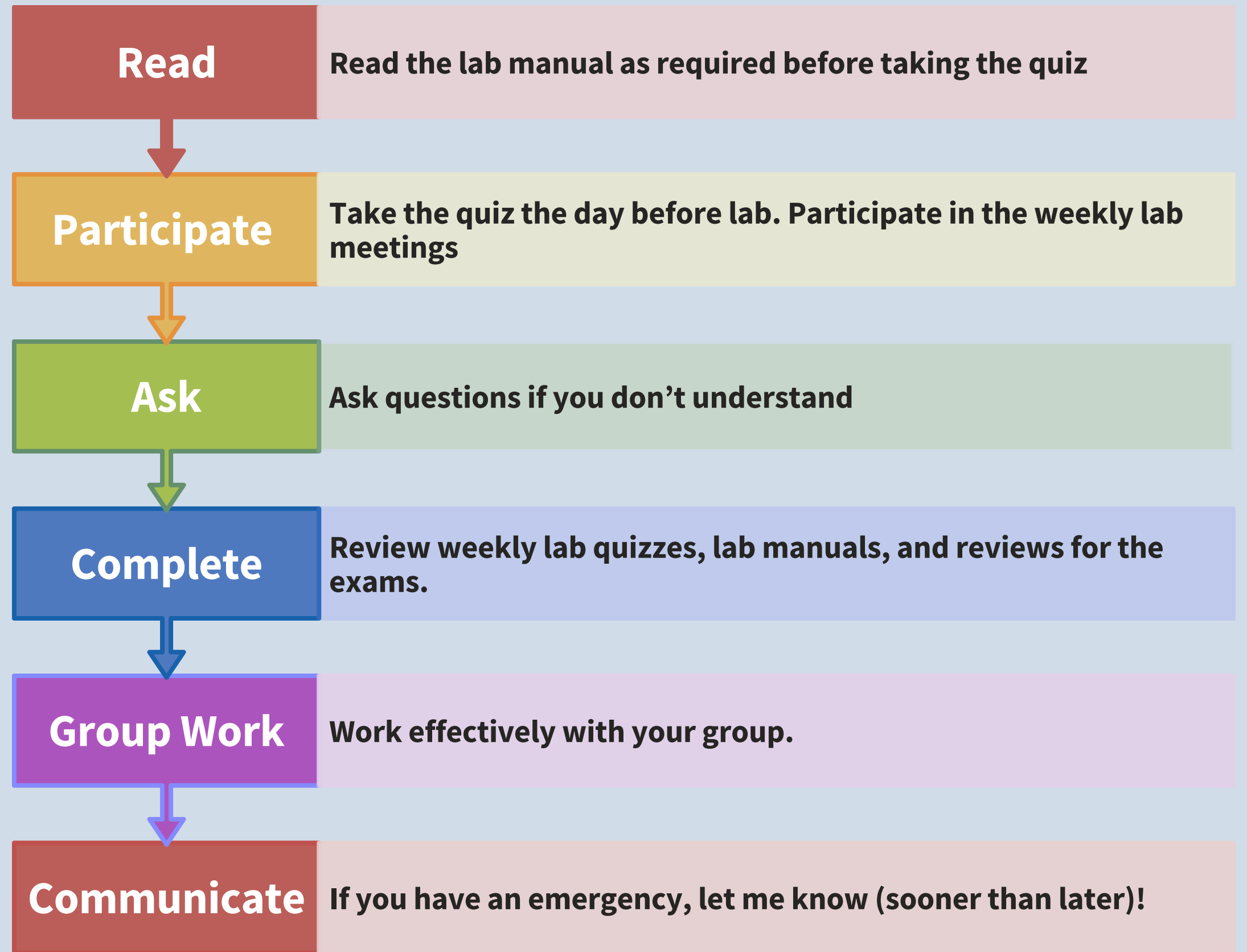

# How can I discuss my grades with my TA?

# UNT Policy
