I. PURPOSE:

The purpose of this course is to provide the students with the basic knowledge and abilities necessary to plan, develop, operate, and maintain a variety of park, recreation, and sport related areas and facilities. Students will be introduced to principles and practices related to planning capital development projects which includes: master planning, facility design and construction, ADA's relevance to capital projects, and maintenance principles and practices. Relevance to real work application will be provided through article readings.

- 1. understand the impact of the built environment on quality of life;
- 2. implement the master planning process;
- 3. conduct a needs analysis;
- 4. understand facility financing strategies;
- 5. understand the facility planning process;
- 6. understand the bidding process;
- 7. understand the design and assessment of playgrounds;
- 8. apply the Americans with Disabilities Act to facility planning;
- 9. understand principles of maintenance
