Prerequisites:

- Two semesters Vocal Jazz Techniques (B minimum)
- Upper Division Exam (or its equivalent)
- Pass Improvisation Continuation Exam (Pass FIPE for Grad. Improv students)

Absences are limited to two for the semester. Excess will lower your semester grade one letter.

Grading: weekly, and determined by the quality of preparation and the musicality of the assignments. The final semester grade will be calculated from:

- Weekly grades, averaged 70%
- Mid-term & final exam 10%, 20%

Content: Vocal Jazz Styles serves as the final class experience for the vocal jazz program, and is taken in the semester prior to the vocal jazz senior recital. The course focuses upon putting together the skills that have been collected throughout the curriculum and having an artistic and musically holistic (and REALISTIC) view of using those skills. Advanced Jazz Improvisation (for Vocalists) will require additional work and a higher level of performance on the same material as that of the Vocal Jazz Styles student's assignments. Areas of focus include, but are not limited to:

- 1. **Performance and improvisation** in three styles of vocal jazz:
 - Swing tunes and blues
 - Straight-eighth tunes, featuring syllabic and lyric improvisation
 - Ballads, featuring lyric improvisation
- 2. Piano skills
- 3. Creating programming

Schedule:

Week 1

Tues 1/15/13 First meeting; discuss purpose and goals of class

Thurs 1/17 Blues handout. "Shape" handout.

ASSIGNMENT: Play blues bass line @ 2 & 4 = 50 - 60 with good time feel by Tuesday. Play r.h. comping figures the same. Not together yet.

Week 2

- Tues 1/22 Due: Piano blues assignment. "Chord Surfing" handout.

 ASSIGNMENT: Put together w/ 2 hands. Practice surfing.
- Thurs 1/24 Due: Piano blues 2 hands
 "Methods of Shedding Changes" handout.

 ASSIGNMENT: Shed changes to "Autumn Leaves" voice & piano.

Week 3

- Tues 1/29 Due: "Autumn", a cappella, one chorus. Motivic development techniques. ASSIGNMENT: Motives ONLY for 1 chorus, free on the 2nd.
- Thurs 1/31 Due: "Autumn", pt. 2. Play changes. Record & listen.

Week 4

- Tues 2/5 Listen to the rest. Choose one attribute to focus on improving. Re-record. ASSIGNMENT: Shed "Have You Met Miss Jones" voice & piano.
- Thurs 2/7 "Have You Met Miss Jones" thru practice methods

Week 5

- Tues 2/12 Due: "Miss Jones"/"Joyspring" @ 160 2 choruses sung, 2nd chorus a cappella. Also play changes at minimum 55 bpm (2-feel bass line). Workout at faster tempos.
- Thurs 2/14 Due: "Miss Jones"/"Joyspring" @ 200. Workout @ 220/240 (Styles/Grad). ASSIGNMENT: Choose swing tune to be approved by instructor

Week 6

- Tues 2/19 Due: "Miss Jones" @ 220/240. Approval of swing tune.
- Thurs 2/21 Due: standard @ 180. Piano skills play in 2 feel with intro (prep for midterm)

Week 7

- Tues 2/26 Due: standard @ 220/240. Prep review for mid-term.
- Thurs 2/28 MIDTERM EXAM: Play and sing a swing tune with a simple arrangement (some improv required somewhere!)

Week 8

- Tues 3/5 Brazilian grooves, pt. 1. ASSIGNMENT: Shed "Corcovado".
- Thurs 3/7 Due: "Corcovado" on piano & voice.

Week 9 – SPRING BREAK

Tues 3/19 Work "Spain" & "Chega de Saudade"

Thurs 3/21 "Spain" or "Chega" on piano & voice (not simultaneously – one at a time!)

Week 11

Tues 3/26 Due: "Spain" – voice – final

Thurs 3/28 Current Artist Reports (5)

ASSIGNMENT: Bring favorite "meaty" ballad.

Week 12

Tues 4/2 Ballads – listen and discuss. Piano skills for ballad playing.

Thurs 4/4 Current Artist Reports (4)

Tues 4/9 Due: ballad with lyric interpretation, melodic improvisation.

Thurs 4/11 Discuss "book" and organization methods. Programming for concerts, clubs, etc. What makes a good set. ASSIGNMENT: Make a 30-min, 60-min program.

Tues 4/16 Discuss programs, pt. 1

Thurs 4/18 Programs, pt. 2

Week 15

Tues 4/23 FINAL ASSIGNMENT: Choose one of the up-tempo selections to sing/blow over; self-accompany on a ballad; accompany someone else on a medium swing tune.

Thurs 4/25 Workout: final prep.
