Objectives: To focus on the technique and style of solo jazz vocal performance, identifying and strengthening underdeveloped skills, and establishing strong practice habits.

Required "equipment" to bring to each lesson:

- 1. Recording device record each lesson and listen back during the week
- 2. Fake book
- 3. Water bottle, full!
- 4. iReal Pro Play Along app (with songs you're working on all in one playlist in your keys)
- 5. Notebook containing your lead sheets and handouts (exercises, etudes, etc.)
- 6. Notebook in which to write down your weekly assignments (can be the same notebook)

Warm your voice up prior to each lesson, even though we will do exercises together in your lesson!

Attendance Policy

- 7. Lessons for vocal jazz majors are 50 minutes long, allowing you 10 minutes to get to your next class. Secondary lessons are 30 minutes long.
- 8. Please arrive to your lesson on time.
- 9. Consistent tardiness will result in a lower overall lesson grade.
- 10. If you miss a lesson without notifying me in advance (unexcused), I will not make up the lesson. Advance notice is defined as 24 hours or more before your scheduled lesson time.
- 11. If you know in advance that you can't make it to a lesson, you have two options: you
- 12. may communicate with another student to swap times for that week (this is the BEST option!). It is YOUR responsibility to contact that student to arrange the swap and then let me know what's happening. Or, you can **tell me more than a day in advance** of your need to cancel and I will attempt to schedule a make-up lesson (although it may not be possible that same week).

Grading

Each week, you'll be given an assignment (transcription, vocal exercises assignment, piano goal, song to memorize and interpret, etc.), which you'll perform at the following lesson. I'll specify my expectations here, grading your weekly assignment performances and recording a weekly grade. Keep your standards high – don't forget, these lessons are for you! Your final grade will consist of:

Lesson grades: 65% (13 weeks x 5% each week – .5% attendance, 4.5% preparedness) Final jury: 35%

- A = Completely prepared; all assignments completed with excellent quality
- B = Moderately prepared; most assignments completed with good quality

C = Somewhat prepared; some assignments completed with good quality, others not at all or poor quality

D = Poorly prepared; most assignments not completed or with very poor quality

F = Not at all prepared.
