# **COMM 4020: Communication Theory** Fall 2025

## **Course Description:**

This course explores the nature and function of theory across the communication studies discipline. This course is reading and writing intensive. You should be prepared to spend significant time reading, reflecting, and writing about challenging material. I hope that this course and the readings challenge you to consider the following questions:

- □ How do you know what you know?
- □ How does communication relate to the world?
- □ How do we as a society create knowledge?
- □ What role does communication play in creating knowledge?

## **Course Goals and Objectives:**

The primary goal of this course is to understand what theory is and how it is connected to scholarship. Thus, the following specific objectives will be achieved in this course:

- □ Understand the role of theory, how theory is evaluated, various approaches to theory in communication studies discipline, and how theory is used in research.
- Critically evaluate theory
- □ Apply a specific theory to a communication event/artifact

COMM 2020: Interpersonal Communication

#### **Required Texts**

You may use the 11<sup>th</sup> edition but some theories we cover in class may not be included.

#### Communication

#### **Course Policies:**

## **Class Attendance and Participation**

Attendance and participation are expected. In order to be successful in this course you will need to come to class prepared, readings completed, and ready to engage in discussion. *Attendance will be taken daily and will impact journal/participation grades*. Excessive absences (more than three) will result in a warning and a deduction of 10 points per class period missed from your journal/participation grade.

### Respect

In this class, respecting one another is essential to an effective learning environment. This classroom is a space in which students are encouraged to engage in open dialogue, and that will NOT be met with any form of disrespect. Throughout the semester, this course will cover topics that may cause some uncomfortable feelings, tension, and even disagreement; however, students are expected to have constructive, respectful conversations. There is a ZERO tolerance policy for disrespecting your peers. It is imperative that students engage with the material with a willingness to learn, participate, and exit their comfort zone with an open mind. Doing so will shape students into better, more empathetic communicators.

#### Mistakes

In order to cultivate an online environment fostering critical thinking and collaborative learning, we need to make room for mistakes. As humans living through a uniquely stressful period in which sociocultural inequities intersect with a global pandemic producing uneven resources and varying levels of access to support, we will all make mistakes. When we do, it is important to learn from them without the expectation that we ourselves, or others, will have the "perfect" response.

#### Intent vs. Impact

When we make mistakes, it is imperative to focus on how our words, actions, and responses impact others, in spite our best intentions. When we focus on intent, the experience of the person affected by the comment or action is invalidated, inherently privileging the feelings of the person responsible for the comment/action, often producing disconnection. However, when we focus on how our words and actions impact others, the experience of the person affected is centered, creating space for apology, growth, and connection. While the "perfect" responses are never be expectation for ourselves or others, centering the impact of our words and actions when we make mistakes is an opportunity to engage in self-reflection, reflexivity, and a deeper understanding what it means to be in community with others.

## Late Work/ Missed Assignments

Each student has an automatic extension of **48 hours** on writing assignments. Thus, if the assignment is due on Thursday at 11:59pm you can turn it in without penalty by Saturday at 11:59pm. If you turn it in after the automatic extension you will receive a zero for the assignment. No other extensions will be considered. This is to help keep us on track. *Extensions do not apply to EXAMS*.

### **Handing in Work**

Formal writing assignments (e.g., Annotations & Final Paper) must be **typed** and **double-spaced** unless otherwise specified. **Assignments, which do not follow these guidelines, will not be graded.** Page length guidelines are based on 12-point Times New Roman Font 1 inch margins expectation (So if you want to use Courier New add a few pages to the requirements). Think hard about self-presentation and impression formation as you put together your assignments. You must use APA format. APA format is not required for journal entries.

## Plagiarism & Originality:

As noted in the University policies, using someone else's words as your own is plagiarism and using your own paper from another class without permission is cheating under the UNT code of student conduct. Our learning goals are directly related to developing research skills, critical thinking skills and becoming content creators. Please note the detailed guidelines for generative AI usage. Failure to follow this policy will result in a deduction for the assignment.

#### **AI Guidelines:**

In this course, students are permitted to use AI-based tools (such as ChatGPT; Microsoft Copilot) on some assignments. AI may be used for pre-task activities such as brainstorming, outlining, and initial research. This level focuses on the effective use of AI for planning, synthesis, and ideation, but assessments should emphasize the ability to develop and refine these ideas independently. You may use AI for planning, idea development, and research. Your final submission should show how you have developed and refined these ideas.

AI-Assisted Assignments must include disclosure statements that cover:

- AI Tool Used: Name of AI product used
- Purpose of the Use: Briefly describe why the tool was used (e.g., assist in research, assist in editing)
- Output Produced: Identify which sections or concepts were influenced by AI.
- Modifications Made: Explain any alterations made to the AI-generated output and how it was adapted for your work.

In addition to your disclosure statements, you will also be required to provide the prompt you designed AND the AI output in addition to your edited assignment. Failure to include a disclosure statement, prompt, and AI output will be considered academic misconduct.

**Grammarly Exception**: Because Grammarly provides recommendations as you write, you will not have to turn in the AI prompt and output. If you are using Grammarly as you write, simply complete the self-disclosure and describe what aspects of Grammarly you are using (e.g., editing suggestions).

Please note that AI results can be biased and inaccurate. It is your responsibility to ensure that the information you use from AI is accurate. Additionally, pay attention to the privacy of your data. Many AI tools will incorporate and use any content you share, so be

careful not to unintentionally share copyrighted materials, original work, or personal information.

Learning how to thoughtfully and strategically use AI-based tools may help you develop your skills, refine your work, and prepare you for your future career. If you have any questions about citation or about what constitutes academic integrity in this course, please feel free to contact me to discuss your concerns.

## **Assignments:**

## Exams (35% of final grade):

This course includes three exams. Each exam will be comprised of multiple choice, true false and essay questions. You will have 1 hour 20 min. to complete the exam. You may use one 8 ½ X 11 piece of paper of handwritten notes that will be submitted with your exam. The exam will be completed in class! A specific review sheet for each exam is posted on Canvas. This course does NOT have a comprehensive final exam—instead you will be completing a major writing assignment. Exam #1 and #2 are worth 125 points; Exam #3 is worth 100 points.

#### Annotated Bibliography (150 points worth 15% of final grade):

You will complete an annotated bibliography on the theory you have selected to use in your communication analysis paper (see below). Gather 6 journal articles or book chapters on the theory. Attempt to find seminal works. All articles should be from academic journals, book chapters or seminal texts. You should provide seminal or key texts in your review—however, I would like for you to find academic articles that apply or review how these concepts fit into Communication Studies. For each journal article/book chapter provide the APA citation and summarize the article in an extended paragraph (200-300 words: can be single-spaced). Please turn into to Turnitin.com on Canvas. AI is allowed for idea generation and editing for this assignment.

## Journal/Participation (200 points for 20% of grade)

This course consists of lectures, class discussions, group and individual activities, special presentations and reflective writing. The lectures are designed to promote dialogue on issues addressed in text chapters and to provide additional information beyond what is included in the text. Class discussions are designed to encourage students to express

opinions, observations, share experiences, and ask questions. Group activities are designed to provide opportunities for students to learn from each other. You will often be asked to engage in reflective writing in preparation for class discussion. You may submit your journals handwritten in class or in a word document via Canvas at midterm and finals. Please feel free to bring a laptop or iPad to type your response in class. You will be asked to complete summaries of discussion, speakers, activities, or self-reflexive writing for your Journal. A blue or green book will be provided if you wish to submit a handwritten journal. AI is not allowed for your journals.

# Communication Analysis Paper (300 points worth 30% of final grade): AI is allowed for idea generation, outlining, and editing for this assignment.

## Topic Paragraph:

Provide a topic paragraph explain the theory and artifact you are planning to examine in your final paper. You must get your theory and artifact approved to continue with this assignment. This is a graded assignment (worth 30 points).

#### Outline:

Fully developed outline or rough draft of final paper is due during individuals meetings held the last two weeks of class. In addition to the outline you should have a complete reference list in APA format completed. This is a graded assignment (worth 70 points).

## Final Paper:

Write an 8-10 page (of text --this page requirement does not include cover page or references) typed double spaced paper that applies a specific theory to a communication event/ artifact (worth 200 points). Each paper should include:

- Introduction- state purpose of paper and preview structure of paper
- Literature Review- discuss purpose of theory selected and break down theory into key functions/components
- Describe Communication Event/Artifact- be sure to describe event/artifact. If possible include copy of event/artifact in an appendix. Inclusion of event/artifact in appendix does NOT mean that you can skip over your description.
- Rationale explain why this theory is appropriate to apply to communication event/ artifact selected.
- Analysis (Apply Theory to Artifact)- explore artifact using the functions or components of the theory you outlined in literature review.
- Discussion- What does your application tell us about the communication event/ artifact? What does your application tell us about the theory?
- Conclusion- review your main points and draw summaries based on your application
- References- Academic books and journal articles in APA style. Avoid textbooks.
   Seminal works for selected theories are required. 8 peer-reviewed academic sources from Communication Studies Journals are required

#### **UNT Policies:**

### **Academic Integrity Standards and Consequences**

- 2. dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems or carrying out other assignments;
- 3. acquisition, without permission, of tests, notes or other academic materials belonging to a faculty or staff member of the University;
- 4. due submission of a paper or project, or re-submission of a paper or project to a different class without express permission from the instructor;
- 5. any other act designed to give a student an unfair advantage on an academic assignment.

<u>Plagiarism.</u> Use of another's thoughts or words without proper attribution in any academic exercise, regardless of the student's intent, including but not limited to:

- 1. the knowing or negligent use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgement or citation.
- 2. The knowing or negligent unacknowledged use of materials prepared by another person or by an agency engaged in selling term papers or other academic materials." (Policies of the University of North Texas, 2012, Section 18.1.16, pg. 3-4).

Rules for citing quotes and ideas can be found in the *Publication Manual of the American Psychological Association*, 7<sup>th</sup> edition. **Please note:** *Intentionality is not an issue with regard to plagiarism. Even if a student plagiarizes without intending to do so, it is still considered plagiarism and will result in the appropriate consequences.* Students are urged to review the parameters and provisions of plagiarism to avoid any potential plagiarism issues.

Punishments for cheating or plagiarism range from a grade of ZERO points on the assignment in question to failure of the course. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

## **University of North Texas Compliance**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.
