#### Course Description and Objectives

Brass Pedagogy is designed to provide the student with the necessary information to be successful as a brass performer and teacher. Topics covered will include teaching fundamentals of brass playing; the history, prominent artists, and major repertoire of each brass instrument; methods for organizing a private studio; working in professional performance and academic environments; and other topics related to brass instruction.

#### Objectives:

- Understand and be able to teach standard brass pedagogical topics through study and observation
- Understand common brass-playing problems and how to address them
- Know the history and standard repertoire of each brass instrument
- Develop a plan for creating a successful teaching studio
- Develop a 4-year high school or undergraduate curriculum for your instrument
- Gain a clear understanding of professionalism in performing and academic workplaces

#### Required Materials:

- Your primary brass instrument
- Required reading materials will be distributed in pdf format via CANVAS throughout the semester

#### Course Assignments and Grading:

Student semester grade will be based on weekly reading discussion grades and several larger assignments due throughout the semester:

- Weekly Discussion Participation - **20%**
- Lesson Observation - **20%**
- Curriculum Project (High school for Undergraduates, College for Graduates) - **20%**
- Pedagogical Problem Presentation - **20%**
- Professional Journal article summary - **20%**

## **Assignment Descriptions**

### ***1. Weekly Discussion Participation***

Students will be prepared to discuss/demonstrate an assigned topic during each class meeting.

### ***2. Professional Journal article summary***

Students will find a pedagogical article from the relevant professional journal and summarize its contents in a brief presentation to the class. **ITG Journal, The Horn Call, ITA Journal, ITEA Journal**

### ***3. Lesson Observation***

Students will observe one applied lesson during the semester. A written summary will be due according to the dates listed in the schedule. The summary should be typed using the document provided.

\*\*Students should always contact a faculty member via email to obtain permission to observe a lesson. The email communication should be professional, respectful, and sent at least a week before the lesson.

### ***4. Curriculum Project***

Students will create a four-year curriculum for their instrument. Undergraduate students will create a curriculum for high school students and Graduate students will create a curriculum for undergraduate study. Students should list which method and etude books, solos, orchestral excerpts, and any other required items desired for each year of a four-year high school /undergraduate program. Also include required performances, technical goals, etc. Required materials should be appropriate to the assigned level.

### ***5. Pedagogical Problem Presentation***

Students will give a 10-minute presentation on a particular pedagogical problem commonly found in brass instrumental study. Students will describe the problem, research the problem, and present potential pedagogical approaches to alleviating the problem. **Graduate** students will present a 15-minute presentation with more depth.

## ACADEMIC INTEGRITY

Financial Aid and Satisfactory Academic Progress

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so. Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended you schedule a meeting with an academic advisor in your college, an advisor in UNT-International or visit the Student Financial Aid and Scholarships office to discuss dropping a course.
