Course Description

• Psychology of the Offender 3530 is a course examining psychological knowledge, phenomena, and theories that are pertinent to the offender and the legal system. Emphasis on how human characteristics and psychological factors influence attitudes, decisions, and behavior throughout the legal process. You will be exposed to guest speakers, directed readings from your textbook and real case studies, videos, simulations, and engaging lecture material. I hope you find this introduction to the as engaging as possible! Be aware that this course covers violent topics such as child molestation, sexual assault, homicide, mass shootings, and police brutality. Review the course calendar to see the topic for each week. If you are unable to engage with any of these topics, I kindly request that you do what's best for your wellness and drop this course. Students who stay enrolled are expected to engage with the material each week and complete assessments that demonstrate understanding and application.

Individual Activities

Individual activities will be provided via Canvas and in class. They are intended to provide you with insight about your own unique perspectives toward the criminal justice system.

Guest Speaker Discussion Questions

Each student will submit three questions to Canvas for the scheduled guest speaker. Questions for the guest speaker must adhere to the instructions located on the assignment document located in Canvas. Students will be given four discussion question (DQ) opportunities, but are only required to complete three.

To earn any points for the Discussion Question assignment, students must attend the entire class on the day of the scheduled guest speaker. Students who submit a Discussion Question to Canvas, but do not attend the entire class, will receive a zero for those questions. Therefore, if you think you will struggle with the content covered by the guest speaker, please do not complete the Discussion Question assignment. I provide 4 guest speaker opportunities, but only require you attend 3. This is to support your wellness.

ACES Certification

The Adverse Childhood Experiences (ACES) Certificate is an online training that you can complete at your own pace. The due date is listed in the syllabus calendar.

Many victims are children who eventually become adults. These adults may or may not become offenders, so it is important we cultivate a better understanding of what happened to people that contributed to their behaviors, thoughts, and emotions. Cultivating a better understanding also helps us to be more empathetic to those who have experienced trauma. An ACES Certification is a great addition to any resume for employment that involves law enforcement, therapy, health care, teaching, non-profit leadership, rehabilitation, corrections, education, and many more.

Team Exams & Individual Quizzes

There will be team exams during the course of the semester. The team exams will be completed in class, and content will be based on lecture material, guest speakers, film, and assigned readings. Students are allowed to bring a standard sheet of paper with handwritten notes on one side to the team exams.

Team Exams

You are required to take 2 team exams. These exams will be taken in class during your team's scheduled class time. Exams will consist of approximately 45 multiple choice questions, each worth 2 points. The exam will be counted out of a possible 100 points, but you can score more than 100 points. In other words, each test will have bonus points available. You should expect most of the questions to be "application." That is, most questions will have an example of a concept, and ask you to identify the example (in contrast to having you identify a definition.) You will have 1 hour to take each exam. Most students will not need the entire time.

Missed Exam

If you miss, fail, or simply don't like a grade on an exam, you can take the **Optional Cumulative Final** during Final's Week. The final will replace your lowest exam grade ONLY IF the final exam grade is higher than your lowest grade. If it is not higher than your lowest exam grade, then the final exam grade will be ignored. Exams are open book and notes. They are NOT open Internet, and any student caught cheating will be subject to the Professional Conduct Policy described below. I highly recommend that you **NOT use your phone or tablet to take an exam**.

Reading Quizzes

Reading Quizzes are individual assignments, and will cover the materials specified in this syllabus. Each quiz is worth 10 points and may be taken from home. I highly recommend that you **NOT use your phone or tablet to take a quiz**. The Canvas app frequently fails, so if you think you can successfully take a quiz while away from a computer, you have been warned.

- Quizzes are due 15 minutes before class begins on the scheduled date listed in the Course Calendar
- Quizzes will have a time limit, so completing the quiz while looking up the answers for every question will be impossible. You only have one chance to complete the quiz, so I highly suggest that you read the assigned pages for the designated quiz before you take it. The quizzes can be accessed by clicking on the "Quizzes" link in the Canvas menu. From there, a list of available quizzes will appear. Simply click on the Reading Quiz you want to take. There are two possible attempts for quizzes. If you choose to take the second attempt, your two quiz scores will be averaged for a final quiz grade. If you are unhappy with your performance on a

- quiz, there is hope! There are more quizzes available than required. Thus, if you miss or fail a quiz, don't worry! You have an additional opportunity to help your grade.
- Once the due date has passed for the quiz, it will be removed from Canvas. I will not allow any student to take a late quiz! Therefore, be mindful of the quiz due dates located in your syllabus.
- To give you some experience in taking quizzes on Canvas, you may take a Practice Quiz. The Practice Quiz will be set up just like a Reading Quiz on Canvas. You can take the Practice Quiz from any computer. To access this quiz, Click Practice Quiz. When the quiz appears, you will have directions to follow. You may take the quiz as many times as you want. It does NOT COUNT for a grade. All quiz scores will be removed.

Checking Your Grade

You can check your earned points anytime in Canvas by clicking on the "Grades" button. Be careful! I use a point system, and offer more opportunities to earn those points than necessary. **Therefore, attend to the number of points you earn since your final grade will be based on those total points, and where they fall on the grading scale located below.**

You have 7 days to dispute a graded assignment from the time it has been entered into Canvas. Once 7 days have passed, the dispute resolution window has closed. Therefore, if I accidentally missed one of your assignments, or did not enter the right grade, or you feel like you provided a response that should get you more points, tell me within 7 days so I can fix it!

CLASS PARTICIPATION AND STUDENT CONDUCT

I will make class an intellectually stimulating and enjoyable experience. Students who ask questions and participate learn more, understand more, and have more fun than students who do not participate in class. In addition, your peers will assess your team performance at the end of the semester. This peer assessment will be a portion of your grade and impact the percentage of points you can earn for the final project.

Professional Conduct and Maintaining Academic Integrity is REQUIRED

- Professional Conduct: Disagreeing with peers is expected, as this course will address numerous sensitive subjects including racism, politics, violence, relationships, identity, and health disparities. Every person in this course has experienced life from their own unique lens. As a participant in a psychology course, you are required to treat each other with respect and professionalism, and in turn, develop your openness and diplomacy skills. Therefore, proof-read your discussion board posts and emails before submitting them. Students who behave in an unprofessional manner will be reported to the Dean of Students and receive an automatic grade of zero for the assignment that is connected with said unprofessionalism. If the unprofessionalism persists, the student will receive an automatic letter grade drop at the end of term or they will automatically fail the course.
 - How to Email Your Professor is a wonderful website that teaches the professional skill of crafting an email that is likely to be well-received. This is a skill that will serve you well throughout your life and career!
- Cheating: I will not tolerate dishonesty. All students are expected to complete assignments on their own. If you are caught cheating, you will receive an automatic zero for the assignment and be reported to the Dean of Students. All of the material you need to complete coursework can be found in assigned course materials. Make sure you provide quotes and a section title for anything you quote directly from sources and a citation for ideas, definitions, or examples you did not invent yourself. Any written work that is basically shortened versions of other people's writing or is written by AI (like a replication of a documentary, an article abstract, or interview from Humans of New York) will receive a grade of 0. Application to your experiences and your perspectives are KEY! Therefore, always provide an APA 7th edition citation in your discussion board if you use an outside source. Here is an example from the APA Style (2025) website for how to cite a website resource at the bottom of your discussion board and within your paragraph to demonstrate what sentence contains the cited information:

During several scheduled classes, I will disseminate in-class assignments and provide guest speaker opportunities. If you are absent, you will not be able to replace those opportunities without a university-recognized excuse. However, please keep in mind that I provide extra assignments to help mitigate any need to be absent, so those will be utilized first.

If you miss more than three weeks of class, you need to schedule a meeting with me to discuss steps to take to withdraw from the course or receive an <u>Incomplete grade</u>. A grade of Incomplete is only an option if you meet <u>university and departmental guidelines</u>, including the completion of at least 60% of the course

assignments and performance equivalent to a C or better when the Incomplete is requested. A grade of Incomplete is not to be used to extend due dates to help boost your current grade, serve as an alternative to a Course Withdrawal, or to provide additional time to complete coursework that you could have completed with proper time management. If you do not meet the requirements for an Incomplete grade, you may meet the requirements for a Late Course Withdrawal due to medical or personal reasons beyond your control. However, you must speak with me or the Dean of Students about an Incomplete or Late Course Withdrawal no later than the first Monday of the week before finals. For example, if finals begin on Monday, December 11th, discussions pertaining to Incomplete Grades or Late Course Withdrawal must occur by Monday, December 4th.

For no reason, other than by orders of the UNT Provost, can this course be altered into a hybrid or online modality. Therefore, consider your wellness and needs before committing to continue with this face-to-face course.

ADA Policy

UNT makes reasonable academic accommodation for students with disabilities. Students seeking accommodation must first register with the Office of Disability Accommodation (ODA) to verify their eligibility. If a disability is verified, the ODA will provide a student with an accommodation letter to be delivered to faculty to begin a private discussion regarding one's specific course needs. Students may request accommodations at any time, however, ODA notices of accommodation should be provided as early as possible in the semester to avoid any delay in implementation. Note that students must obtain a new letter of accommodation for every semester and must meet with each faculty member prior to implementation in each class.

Retention of Student Records and Grade Appeals

Student records pertaining to this course are maintained in a secure location by the instructor of record. All records such as exams, answer sheets (with keys), and written papers submitted during the duration of the course are kept for at least one calendar year after course completion except those assignments and exams that were graded and returned to you. Please retain all graded and returned assignments and exams until you are certain that you are satisfied with how your course performance was scored, documented, and submitted to the UNT system. Coursework completed via the Canvas online system, including grading information and comments, is also stored in a safe electronic environment for one year. Students have the right to view their individual record; however, information about student's records will not be divulged to other individuals without proper written consent. Students are encouraged to review the Public Information Policy and the Family Educational Rights and Privacy Act (FERPA) laws and the University's policy. See UNT Policy 10.10, Records Management and Retention for additional information.

If you believe the final grade submitted to the UNT system is not reflective of your performance, you can begin the formal <u>UNT Grade Appeal</u> process. Students can appeal a grade using this process if at least one of the following is met:

- grade was based on unfair treatment;
- instructor departed from standards set out in the course syllabus without a rational academic reason; or
- an error was made in calculating the grade, including failure to factor an assignment, project, quiz, or examination.

If the student believes that the grade was assigned due to discrimination or sexual harassment, the student must report this belief to the Office of Equal Opportunity. That allegation must be resolved through the UNT Resolution Procedures for Complaints of Discrimination, Harassment, or Retaliation, before the appeal can proceed. Change of a grade due to violations of academic integrity cannot be appealed through this process.

The first step is to communicate with me, the professor, about your concerns. If, after that conversation, we do not agree about your final grade, you can move forward in the appeal process by meeting with the Department Chair, followed by an academic committee, and finally, the Dean. In those reviews, your performance as documented in Canvas and our correspondence throughout the semester will be submitted as evidence for an academic decision.
