Course Description & Objectives:

In this course, we will read and analyze Japanese ghost stories through the ages. The purpose of this course is to learn about Japanese religious thoughts and values as well as cultural aspects that come from those religious values. We will also examine how words, phrases and sentences are used in given contexts in order to become more aware of and sensitive to the use of the target language. We will use reading materials, video clips and movies in this class. You are expected to create ghost stories in Japanese in the semester.

Comprehension sheets (20%): After reading materials or watching video clips/moves, you are expected to complete the comprehension sheets. You must turn in the homework on Canvas according to due dates to receive full credit.

Discussions (25%): After the reading materials, video clips and movies, you are expected to discuss on given topics in Japanese and write your comments to classmates via Canvas discussion board.

Vocabulary Quizzes (20%): Vocabulary quizzes will be given on line at the end of each module. A test includes comprehension questions and short writings in Japanese. The detailed information on quizzes and tests will be given in class.

Creating ghost stories (20%): You are expected to create ghost stories in Japanese and present them online during the semester.

You are expected to submit the assignments online. You will have at least one week to complete each assignments. **No late submission is accepted**. If you miss homework, quizzes, or exams because of an excused absence, you may make up the work, according to a schedule agreed to by you and the professor.

- Avoid using "text-talk" unless explicitly permitted by your instructor.
- Proofread and fact-check your sources.
- Keep in mind that online posts can be permanent, so think first before you type.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following: (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email <u>internationaladvising@unt.edu</u>) to get clarification before the one-week deadline.

Student Verification

- Completion of 5 semester courses of Japanese language study at the college level
- GPA of 3.5 in Japanese language courses
- Overall GPA of 3.0
