Description:

Study of public relations trends and principles and how they relate to cases involving organizations and institutions in the profit and non-profit sectors. Attention to the use of proper public relations tools in meeting the needs of each organization's public.

Course Overview, Objectives and Student Learning Outcomes:

This course is designed to help you convert the public relations theory and skills you've learned in prior courses into real-world, practical knowledge of how PR practitioners apply strategy, tactics and tools into actionable plans for managing all aspects of communication and relationship management. To do this, we'll focus on case studies of real-world incidents, some of which you should be familiar with from recent news.

To be a valued practitioner of public relations – in business, government, not-for-profit or any number of other enterprises – you MUST be a student of the media. That means you need to read the news, follow the broadcasts, scroll the social media feeds and generally stay on top of a host of current affairs.

Public relations is also a personal skills-based business, so we will also focus on your ability to absorb, process and share your thinking and opinions – individually and in teams – so that you can continue to develop the professional skills required in the workplace. By the end of the course, you should be able to quickly learn, synthesize and present sound thinking on PR strategies and media management as learned through case studies.

This will be an intensive course, with weekly readings and assignments and constant challenges. So please come prepared each week to give it your very best.

Moreover, public relations is an active, engaged field – one where you are expected to be alert, engaged and on the front lines at all times. So you are encouraged to be involved with all discussions, contribute to what we're learning and collaborate closely with others to make this an interactive and meaningful experience.

By the end of this course, you should be able to:

- 1. Understand how public relations works in today's world;
- 2. Appreciate the importance of research in solving public relations problems;
- 3. Comprehend and apply strategic planning;
- 4. Evaluate success or failure of various public relations programs and campaigns;
- 5. Use environmental scanning to identify current events and issues that can have PR impact on today's organizations;
- 6. Develop high ethical standards for public relations practices;
- 7. Demonstrate an understanding of the history and role of professionals and institutions in shaping communications;
- 8. Demonstrate an understanding of diversity in domestic society in relation to mass communications;
- 9. Demonstrate an understanding of the diversity of peoples and cultures and of the significance and impact of mass communications in a global society;
- 10. Demonstrate an understanding of professional ethical principles and work ethically in pursuit of truth, accuracy, fairness and diversity;
- 11. Think critically, creatively and independently;
- 12. Conduct research and evaluate information by methods appropriate to the communications professions in which they work.

Course Policies

Attendance Policy:

You are all juniors, seniors and graduate students in this course, so your next stop will be a professional position somewhere out in the working world. Therefore, our attendance policy will mirror the expectations of a professional employer. In short, you are expected to attend EVERY scheduled class (for the entire duration of the class), just as you would be expected to show up for work every day. Much of what we cover will extend week-to-week, so it's vital that you attend each class.

If you must miss or missed a class for an excused absence (i.e. serious illness, participation in an official university function, religious observance, etc.), you must submit third-party documentation within a week of your absence. Please see the UNT policy for details. While issues such as lack of sleep, computer glitches, car trouble or work schedules are awful, they are not excused absences. (You can't receive participation points if you're not here, regardless of reason.) You will have one week to make up in-class work for an excused absence once that documentation is received. It is your responsibility to follow up on this.

Class meetings are NOT recorded, so please get notes on what you missed from a classmate. Graduate students who miss three or more class meetings will not successfully complete the course.

Academic Honesty:

Public relations professionals – and students - must convey their thoughts in their own words. Cutting and pasting text from an online or written source – *even if the source* is *cited* – can be considered copyright infringement or plagiarism in the professional sector. People lose their jobs over it.

Your work will be run through TurnItIn software. The system will give you a report within a few minutes regarding how much content is similar to other sources. My basic rule of thumb is to rewrite the document if you have a similarity score of 20 percent or higher. (I disregard content that is flagged in your reference listings.)

Make sure what you write is accurate and reliable; fabrication can also lead to unemployment.

Assignments that contain AI-generated, fabricated, plagiarized or copyrighted material will earn a ZERO and will be reported to the Dean of Students. This includes work products previously produced by other students. ANY assignment, quiz or test which demonstrates dishonesty will receive a zero. Recirculating assignments done in classes is academic dishonesty, and those assignments will receive zeros and be reported as well. See the University and MSOJ Academic Integrity policies for more details.

Use of Artificial Intelligence (AI)

I want you to engage deeply with the materials and develop your own critical thinking and writing skills. For this reason, the use of Generative AI (GenAI) tools like Claude, ChatGPT, Gemini, Bard and others is not permitted. While these tools can be helpful in some contexts, they do not align with our goal of fostering the development of your independent thinking.

Using GenAI to complete any part of an assignment, exam, or coursework will be considered a violation of academic integrity, as it prevents the development of your own skills, and will be addressed according to the Student Academic Integrity policy. Additionally, tools like Grammarly (and other grammar checking programs), predictive text, speech-to-text, and translation tools are not allowed as they blur authorship and misrepresent your independent work. All work must be your own.

Deadlines and Late Work:

Deadlines are a critical part of public relations work. Your assignments are due on or before the deadline – even if you are absent. All deadlines are firm.

Preparation and Participation:

I want students to be actively involved in class and to feel comfortable expressing their thoughts and opinions. Please do the homework and be prepared to share your insights/reactions in class and in small groups. Be respectful of others' thoughts, even if you do not agree.

In the event you are unable to attend class, please ask a classmate for an update on what was covered.

Course Content

Expect to have a reading quiz and a written assignment due every week. Assignment and grading information is subject to change pending the needs of the class. Please see the Canvas modules for full

and up-to-date information.

In-class assignments 50 points

3 assignments at 25 points each

We will be working in-class as well. These are smaller, timed assignments. Some are individual assignments, and some are group projects. They must be completed before the end of the class period and cannot be made up if a student has an unexcused absence. Three are scheduled; I will drop your lowest score.

Class participation 110 points

13 classes at 10 points each

A case study class hinges on the involvement of and interaction among students. I am there to lead you into your own analyses of situations rather than provide you with the answers. Therefore, it's critical that you are well prepared for class and that you actively share your knowledge and perspectives on the issues we'll be discussing. You will receive a participation grade that is based on how you contribute to class and small group discussions. Each class is worth 10 points. Participation points CANNOT be made up with absences; however, I will drop your two lowest scores.

Current event analysis 100 points

4 assignments at 25 points each

Public relations is a fast-moving field, so it's imperative that we stay up on daily and weekly events. These reports will help you develop environmental scanning skills and keep up with industry developments. No scores dropped.

Quizzes 120 points

13 quizzes x 10 points each.

These quizzes must be completed before our meetings. They cover the readings for that particular week. You will need to know this content for our discussions. I will drop your lowest score.

Case analyses from textbook 75 points

3 assignments x 25 points each

These analyses are based on the cases presented in the textbook. Details will be discussed via Canvas and class. No scores dropped.

Case study for undergrads only 100 points

Students will do a deep dive on one case study during the course of the semester to help you analyze and understand why organizations respond the way they do and the implications of those responses.

Research is a fundamental part of creating an analysis of any type of work, so you will be expected to research at least seven separate sources and provide proper citations (APA Style) for reference.

Grad students: Institute for PR Research-Page Student Case Study Competition 250 points

This course is a hybrid course mixing graduate-level learning along with undergraduate studies. As graduate students, you are expected to be highly competent practitioners of your craft, and so more is expected of you in this course.

Sharing your knowledge with others is fundamental to the graduate experience, so each of you will be expected to develop and finalize an entry for the IPR-Page Society 2026 Student Case Study Competition. This entry includes a detailed case study, teaching notes and presentation. You will be working in pairs. (Solo projects will be considered on a case-by-case basis.)

Grading

Your final grade is based on the total number of points you accumulate throughout the course. It is based on the scale below.

Other grading information

- **Turn-around time:** I aim to return graded work to you within two weeks of the due date. When this is not possible, I will send an announcement to the class.
- Grade disputes: You are required to wait 24 hours before contacting me to dispute an assignment grade. Within that time, I expect that you will review the assignment details and reflect on the quality of the work you turned in. If you would still like to meet, email me to set up a meeting (I cannot discuss grades over email). You should come to our scheduled meeting with specific examples that demonstrate that you earned a higher grade than you received. If you miss your scheduled meeting, you forfeit your

right to a grade dispute. If you do not contact me to schedule a meeting within seven days of receiving your grade, you also forfeit your right to a grade dispute.

• Extra credit opportunities: There are a few extra credit opportunities in the course, so please take full advantage of them. These may take the form of unannounced in-class activities, and these items cannot be made up in the event of any absence. Because these items are available to help boost your grade, I do not round-up grades at the end of the semester, and I do not respond to requests asking for this consideration.

JOURNALISM REQUIREMENTS & GUIDELINES

JOURNALISM COURSE REGISTRATION

By registering for this course, you are stating that you have taken the required prerequisites according to your catalog year and major/minor status. If the instructor later determines that you haven't taken and passed these requirements, then you may be dropped at any point in the semester. If you have questions about your prerequisites, please see an advisor.

A journalism major enrolled in any restricted 3000 and 4000 level classes must have taken and passed all foundational courses. Students must earn and maintain a 2.5 UNT and/or overall GPA (depending upon catalog year) to be eligible for major-level courses.

RE-TAKING FAILED JOURNALISM CLASSES

Students will not be allowed to automatically take a failed journalism course more than two times. Once you have failed a journalism course twice, you will not be allowed to enroll in that course for one calendar year after the date you received the second failing grade. Once a student has waited one calendar year after failing a course twice, the student may submit a written appeal to the director to be approved to enroll a third time. Students will not be allowed to re-take a failed journalism course more than three times.

TEXTBOOK POLICY

The Mayborn School of Journalism doesn't require students to purchase textbooks from the University Bookstore. Many are available through other bookstores or online.

FINANCIAL AID SATISFACTORY ACADEMIC PROGRESS (SAP) UNDERGRADUATES

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose financial aid eligibility.

The school's policy aligns with UNT Policy 06.003 and requires reporting any act of academic dishonesty to the Office for Academic Integrity for investigation. If the student has a previous confirmed offense (whether the first offense was in the journalism school or another university department) and the student is found to have committed another offense, the department will request the additional sanction of removing the student from the Mayborn School of Journalism. The student may appeal to the Office for Academic Integrity, which ensures due process and allows the student to remain in class pending the appeal.

This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in multiple on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Advising Office. The UNT International Advising Office has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, students should contact the UNT International Advising Office (telephone 940-565-2195 or email international@unt.edu) to get clarification before the one-week deadline.

EMERGENCY NOTIFICATION & PROCEDURES
