**COURSE DESCRIPTION:** Child development theory and creativity examined in relation to contemporary practice in the elementary art classroom. Partial field experience component (25 hours) and practice TEXES Art EC-12 Exam required.

Prerequisite(s): ARTE 3753 with a grade of C or better and admission to the Art Education BFA program.

- <u>Unit Plan Presentation</u> (25% of final grade) Students will work collaboratively to create and present an overview of their unit plan. See Canvas assignment for further details.
- <u>Unit Plan</u> (25% of final grade) Students will work collaboratively to create and submit a completed unit plan for elementary art students. See Canvas assignment for further details.
- <u>Class Participation</u> (10% of final grade) Students will earn 'participation points' by engaging with the learning content presented in each class.
