COURSE DESCRIPTION

This course is **one 1 credit** hour. It is the first of three **required** professional development courses in the G Brint Ryan College of Business. These courses are designed to build upon each other and help students develop strategies to become career ready. In BUSI 1200, students integrate knowledge of self and career exploration. This course will introduce students to basic professional development concepts necessary to perform and succeed in a business environment. Coursework in BUSI 1200 is designed for students to begin building their professional toolkit.

Course Learning Outcomes

Students will gain knowledge and develop skills required to successfully navigate a career in business. This course will specifically focus on "soft" skills that are a valuable asset in career development. Students will:

- · Identify personal and career goals
- Complete various self-assessment tools as it relates to career aspirations
- Create and deliver an elevator speech
- Learn to effectively communicate values, skills and experiences and goals to potential employers
- · Create, format and tailor a professional cover letter and resume
- Develop networking strategies relevant to professional development, including creating a LinkedIn Profile
- Learn the basic components of career research and explore opportunities in demonstrated field of interest
- Gain skills necessary to having a successful interview
- Explore strategies and resources for academic success
- Utilize the RCOB EDGE Program mobile app to track and build competencies
- Understand how AI can assist with career readiness
- Learn the process for acquiring an internship for class credit
- Demonstrate awareness of behavioral norms within a business in relationship to communication, appearance, business etiquette, and day-to-day business functions.

USE OF TECHNOLOGY

Personal technology is not to be used during class unless we are working on a tech-driven project together or if the instructor grants explicit permission. Texting, watching videos, web surfing, listening to music, having phone conversations, etc. is distracting to your peers, inconsiderate of your instructor, and is unprofessional conduct. COURSE STRUCTURE

This course is *in person*. It includes a combination of classroom instruction, guest speakers, and relevant assignments to build competency in professional and career development. Students will be required to do some tasks outside of class on their own time.

ATTENDANCE

This is an **8-week course**, which means we will cover a full semester in half the time. The most basic component of professional development is being present. Therefore, class attendance is a major component of your grade. Students who are habitually tardy to class will be considered absent.

- Class attendance is required. Attendance points are factored into your final course grade.
- We meet **twice a week for eight (8) weeks**. There will be valuable interactions and information presented during class time.
- If you miss class, you will ask a classmate, not the instructor, to explain what you missed.
- If you miss class, you are still responsible for the material covered and for completing any assignments on time.
- Excused absences are at the discretion of the instructor and if the absence is excused the instructor will provide guidance on makeup work, if any. Students should be prepared to produce documentation of the reason for their absences and may be asked to contact the Dean of Students Office for further verification.

GRADING

Points will be assigned for attendance and for all assignments. Although the Canvas grade book records completion of assignments, the Canvas grade book is NOT USED to calculate final grades because the calculations can be inaccurate. Students with questions about grades should contact the instructor directly and promptly. Grading questions submitted in the final week of classes or after grades are posted are NOT considered timely inquiries and the likelihood of obtaining assistance with untimely inquiries is very low.

LATE WORK

All assignments are to be submitted as instructed, either during class time or to Canvas by **11:59 PM on the due date** (unless otherwise indicated). Assignments turned in on time <u>and</u> fully completed as instructed will receive the full points. Persons with mobility impairments who are unable to safely exit the building should move to a designated area of refuge and await assistance from emergency responders. All building occupants should immediately evacuate the building and proceed to the south side of Crumley Hall in the grassy area, west of parking lot 24.
