Course Objectives:

Students will learn and grasp techniques, color theory, and composition catered to the level of Painting Two. Various subject matter will be explored to push students to think conceptually. At the end of the course, they will have a cohesive body of work in both physical and digital format, as well as a drafted artist statement. Throughout the semester, students will have a stronger understanding of contemporary artists through required research. ***Risks & creativity are highly encouraged in this class!***

ATTENDANCE POLICY: Attendance is a crucial part of this course, as demonstration and interaction with myself and your classmates will provide information and considerations otherwise unavailable. Ten minutes after the start of class, as student is considered tardy.

Three absences will be tolerated.

More than three absences will require a note from a doctor or a note from the art office excusing the absence for a reason covered under UNT policy 06.039 (Student Attendance and Authorized Absences) in order to be counted as excused.

More than three absences will lower your final grade by one letter grade per additional absence (4 or more)

Critiques missed may not be made up and grades will reflect the student's failure to participate in the critique discussions.

ASSIGNMENTS & GRADING

There are **FIVE major projects**, each are graded out of 100. You can only gain full points if you are present during each **critique and submit a digital image** of each piece through canvas. I like to give students the option to choose how deep they can delve into each project conceptually. These are meant to be guidelines to help you navigate your paintings, not restrictions. If you'd like more flexibility to be able to be more creative with your work please talk to me, I am always happy to make exceptions! Size can be discussed... for instance if you'd like to work small, you can create multiple, vs one large canvas. Canvases or Panels are preferred.

1. Narrative (Intentional brushstrokes)

Option A: Everyday life, small moments

Option B: Core memories, childhood, coming of age

Option C: Your dreams (What did you dream about?) or a Fantasy moment

2. Figure / Portrait (Layers, glazing)

Option A: Depicting a human form

Option B: Containing someone who impacted you heavily, positively or negatively

Option C: Specific body parts, or the human condition. What does being human mean to you?

3. Landscape / Architecture (Depth & Perspective)

Option A: Notable scene or building that stands out to you, what you think about often

Option B: A place you wish you could go to, or doesn't exist anymore

Option C: A place you have negative feelings towards for any reason

4. Abstracted / Experimental (Color theory)

Option A: Stick to just 2-6 colors

Option B: Focus on geometric or organic forms

Option C: Sensory experience, such as the smell of a candle, noises, songs, what do you see?

5. Open Concept (Artist research)

- Look up one contemporary artist and write a page about what they do, why you find them interesting, and what you implemented from their practice (conceptually or visually).

Social media artists are ok, but blue chip gallery artists are preferred.

You are also encouraged to explore mediums with this piece! Mixed media is ok! Different shaped panels are ok! Ratio is at least 60% painting... come talk to me about it.

- At the end of the semester, draft an artist statement. I'll go over this in class

A = Excellent (100-90%) Great photo documentation quality, participation in critique, stellar effort in painting (risk taking, time spent either ideation or final product)

B = Above Average (89-80%) Ok photo quality, present during critique, good painting effort

C = Average (79-70%) Not great photo, you showed up and did the painting bare minimum

D = Inferior (69-60%) You did like half of the work

F = Failure (59% or below) You didn't do most of the work or just never showed up

PHOTO DOCUMENTATION + RESOURCES:

Aim for bright, even, and clear lighting. No distractions in the background, and give enough space or breathing room for the edges of your work. This will be great experience for documenting your work to submit for future opportunities. Image quality is extremely important.

Materials List

Whatever you have from Painting One can be carried over and used for this course.

Below is what I prefer, or are the bare minimum materials. Stick to gamsol instead of turpentine due to the toxicity levels.

- Canvases, or Panels (Premade or you can make your own... I will let you know the dimensions required before each project)
- Gesso
- Palette knife (Style optional—you may want to try out a couple of different designs)
- Brushes: range of small to large sizes... one each—Flat 8, 10, 12, Bright 8, 10.
Please buy good quality brushes. They will be worth the investment and will last for years if cared for properly!
- Gesso Brush: 2" or larger latex house painting brush
- Paint: Colors I prefer, since I recommend you **make your own black**: Cadmium Red, Cadmium Yellow (not "Pale"), Ultramarine Blue, Titanium White (Large (200ml) Tube...you will probably use more than one of these this semester!). Optional colors: Naples Yellow, Burnt Sienna, Cobalt Blue, Raw Umber, Pthlalo Green. Mediums for Oil Paint. Liquin or other brands of alkyd medium. You may also mix your own medium with pure gum turpentine, dammar varnish, linseed and/or stand oil (small amounts of turpentine will be allowed in the form of painting medium)
- Rags: Rags are a must! Cotton painting rags from Home Depot or Lowe's are a good buy. You can also recycle old t-shirts and other cotton fabrics.
- Containers for medium and thinners. Lids are strongly suggested! Large Coffee cans are great, as are mason type jars. Tin foil, if no lids.
- Optional for Oil Painting: Liquin, Galkyd, Galkyd Lite, Galkyd Slow Dry, Dammar Varnish or Crystals, Walnut Oil, Poppy Oil, Stand oil, and/or linseed oil. Do not buy boiled linseed oil from hardware stores. This is not suitable for oil painting.
- Other options: Boraxo soap for cleaning brushes, surgical or cleaning gloves, sponges, modeling paste, acrylic mediums and additives, Lava soap, Fast Orange, or other mechanic's type hand cleaners.
- Other items may need to be purchased throughout the semester. You will be expected to replenish supplies as you run out.

IMPORTANT NOTICE FOR F-1 STUDENTS TAKING DISTANCE EDUCATION COURSES

Federal Regulation To read detailed Immigration and Customs Enforcement regulations for F-1 students taking

online courses, please go to the Electronic Code of Federal Regulations website (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6) (i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which

must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.
