

MUJS 4720 – 710 Jazz Senior Recital Capstone

Applied lessons in Jazz Composition & Arranging

Course objective: a 45-minute recital that blends the music-writing component with jazz performance. The writing portion must comprise 25 minutes and include five pieces of contrasting moods and styles: swing, Latin, ballad, blues, modern. Two arrangements must be orchestrated for large jazz ensemble. The remaining three must be for 2-horn, 3-horn, and 4 or 5-horn combinations with rhythm section.

There are thirteen 50-minute private lessons during this semester; any remaining lessons beyond the recital date will be used for future planning and continuing pursuit of the craft.

In addition to the music composition, arranging, and manuscript preparation, conducting will also be discussed. This includes rehearsal techniques, time management, organizing ensemble members, scheduling rehearsals, and booking a venue along with an audio engineer, recording engineer, piano tuner, and stage hands (student friends).

Before the official printing, the student must also write program notes for each piece and submit them along with a recital program for preliminary review by Professor DeRosa.

Attendance is essential for adequate preparation. With any anticipated absence, it is customary to notify the professor via e-mail as soon as possible. The professor cannot guarantee that a student absence (loss of a lesson) will be rescheduled but all decent attempts will be made if possible.

Recital attire: concert black (shirt, pants, shoes, etc.) for the ensemble performers. Appropriate concert dress (jacket and tie for men, or the similar equivalent for ladies) for the featured student writer.
