### ***Course description***

Business nowadays rely heavily on data to make informed decisions. Business analytics uses statistical and machine learning techniques to extract valuable information out of large volume of data and to discover actionable insights in business contexts. Python is the most popular programming language for advanced business analytics. This course aims to teach how to perform business analytics tasks using Python. We will cover basic programming concepts in Python and useful packages for business analytics such as NumPy, Pandas, Matplotlib, ScikitLearn. Students will learn to identify data related business problems in today's information-rich environments and get hands-on Python programming to solve problems.

The course will cover, but are not limited to, the following:

- 1) The concepts of business analytics
- 2) Python programming basics
- 3) Web scraping, JSON data, packages for business analytics
- 3) Solving real-world problems using knowledge and skills learned in this course

### ***Learning objectives***

Upon completing this course, students will be able to apply their analytical and programming capabilities to build innovative business solutions using large datasets. They should be able to:

- Gain an in-depth knowledge of native data types and control structures in Python
- Understand fundamental techniques to implement tasks in Python
- Prepare and organize data for data analysis
- Perform data mining tasks such as data visualization, prediction, classification, etc. using Python
- Integrate knowledge and skills learned in this course to provide an analytic solution to a business problem, from data collection, data cleaning, data exploration, data analysis, results interpretation and presentation, to action plan.

### ***Course prerequisites***

Although we will use Python programming language to perform our hands-on tasks, you **do not need** to have programming experience to excel in this course. I will guide you through the very basics and in the end, you will be comfortable writing your own Python programs.

1. The course is oriented to problem solving with programming. Concepts and skills are demonstrated through examples and cases.
2. There are three modules.
  - Module 1:** Python Programming Basics: Basics, flow control, functions, lists, files, web scraping, JSON data, etc.
  - Module 2:** Python Programming for Business Analytics: Numpy, Pandas, Matplotlib, ScikitLearn and use them for data preparation, dimension reduction, exploration, prediction/classification models, and performance evaluation
  - Module 3:** Putting everything together. We are going to use everything we have learned to solve real business cases.

## Assignments

We have six homework assignments throughout the semester. All assignments must be submitted through Canvas. Alternative submission methods (e.g., by paper, by e-mail, or on disk/USB drive) is not acceptable unless prior permission of the instructor is obtained. **Submissions after the deadline will not be accepted.** All work turned in after the deadline will receive a grade of zero unless the student has a [university-excused absence](#) and provides documentation with 48 hours of the missed deadline.

It is expected that you finish the assignments on individual basis. **Copying off from others' work is strictly prohibited.**

Assignment grades will be posted within a week after the submission. When this is not possible, I will send an announcement to the class.

## Project

You will form a group of **4-5 people**. The details of project requirements will be available in a separate document provided to the students. The goal of this project is to successfully implement one or more of the data analytic techniques to solve a real-world problem. At the end of the semester, the final deliverables of this project include **a project report** and **a recorded presentation** given by each group. If the project is not completed by the final deadline, students will be evaluated on their progress and on the deliverables that have been submitted prior to this deadline.

## Grade Disputes

You are required to wait 24 hours before contacting me to dispute a grade. Within that time, I expect that you will review the assignment details and reflect on the quality of the work you turned in. If you would still like to meet, email me to set up a meeting (I cannot discuss grades over email). You should come to our scheduled meeting with specifics that demonstrate that you earned a higher grade than you received. If you miss your scheduled meeting, you forfeit your right to a grade dispute. If you do not contact me to schedule a meeting within seven days of receiving your grade, you also forfeit your right to a grade dispute.

### Important Notice for F-1 Students taking Distance Education Courses

#### Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

### University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
