### *Course description*

Business nowadays relies heavily on data to make informed decisions. Data mining uses statistical and machine learning techniques to extract valuable information out of large volume of data and to discover actionable insights in business contexts. Students will learn to identify data related business problems in today's information-rich environments and get hands-on with various data mining techniques to solve problems.

The course will cover, but are not limited to, the following:

- 1) The concepts of business analytics
- 2) data mining techniques and applications using R (e.g., data visualization, regression, classification, clustering, association rule analysis)
- 3) Solving real-world problems using knowledge and skills learned in this course

### *Learning objectives*

Upon completing this course, students will be able to apply their analytical capabilities to build innovative business solutions using large datasets. They should be able to:

- Articulate analytics-related business problems and identify data needed to solve problems
- Prepare and organize data for data analysis
- Understand when and how each data mining technique can be used
- Perform data mining tasks such as data visualization, prediction, classification, etc. using R
- Integrate knowledge and skills learned in this course to provide an analytic solution to a business problem, from data collection, data cleaning, data exploration, data analysis, results interpretation and presentation, to action plan.

### **Course prerequisites**

Although this course does not have specified prerequisite courses, it is ideal that you refamiliarize yourself with the two statistic courses you took. We will take some class time to review certain concepts in statistics.

Although we will use R programming language to perform our hands-on tasks, you **do not need** to have any programming experience to excel in this course. I will guide you through the very basics and in the end, you will be comfortable writing your own R programs.

### **Course structure**

1. The course includes both lecture and hands-on practices in class. Knowledge and concepts are explained in lectures and programming in R will be demonstrated.
2. There are four modules.
  - Module 1:** Understand Business analytics and Data. This module covers the following: Introduction to Business Analytics; Understand data/Review of statistic concepts; Explore data/Data visualization
  - Module 2:** Supervised Learning - Prediction/Classification Models and Performance Evaluation. This module explains fundamental data mining techniques for prediction and classification problems, including linear regression, logistic regression, tree methods, etc.
  - Module 3:** Unsupervised Learning - Explore patterns in raw data. This module introduces three methods: association rules, cluster analysis and handling time-series data.
  - Module 4:** Putting everything together. We are going to use everything we have learned to solve real business cases.
3. Tentative Schedule: This is a tentative schedule. Dates and topics of lecture are subject to change. I will try my best to keep the schedule and any changes will be announced in advance.

## Assignments

We have six homework assignments throughout the semester. All assignments must be submitted through Canvas. Alternative submission methods (e.g., by paper, by e-mail, or on disk/USB drive) is not acceptable unless prior permission of the instructor is obtained. **Submissions after the deadline will not be accepted.** All work turned in after the deadline will receive a grade of zero unless the student has a [university-excused absence](#) and provides documentation with 48 hours of the missed deadline.

It is expected that you finish the assignments on individual basis. **Copying off from others' work is strictly prohibited.**

Assignment grades will be posted within a week after the submission. When this is not possible, I will send an announcement to the class.

## Quizzes

A quiz will be given at the beginning of each class indicated in the schedule. The purpose of the quizzes is to review what we have learned in the previous class and set you in the state to learn new materials.

## Participation

The participation portion of your grade is affected by your involvement in the classroom discussions and activities. As every class session will be recorded, we can refer to but not limited to the following. First, your attendance will be kept on record by Zoom. Second, you can raise or answer questions using either your voice or chat messages. Third, we will have breakout room activities, during which you make contributions to the group discussion.

Over the semester, you can have **three classes** excused from participation evaluation – we all have those days that we do not want to talk. You do not need to tell me which classes you intend to be excused. I will pick your best classes for the grading purpose. This is different from attendance policy, which requires you to attend **ALL** classes.

## Grade Disputes

You are required to wait 24 hours before contacting me to dispute a grade. Within that time, I expect that you will review the assignment details and reflect on the quality of the work you turned in and discuss with the TA, who is going to grade your assignments. If you would still like to meet, email me to set up a meeting (I cannot discuss grades over email). You should come to our scheduled meeting with specific

examples that demonstrate that you earned a higher grade than you received. If you miss your scheduled meeting, you forfeit your right to a grade dispute. If you do not contact me to schedule a meeting within seven days of receiving your grade, you also forfeit your right to a grade dispute.

## Important Notice for F-1 Students taking Distance Education Courses

### Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

### University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
