# **Course Description**

Strings Class is a fundamental string techniques and pedagogy course designed to develop basic performance and teaching skills for violin, viola, cello, and/or bass. This course will help students learn beginner playing techniques as well as best practices for teaching individuals and ensembles. This course is primarily an opportunity for you to learn how to teach yourself and others through thoughtful practice, reading, and reflection. There are no prerequisites for enrollment, and mastery of a string instrument is not expected by the end of this course. Regardless of prior experience, students should demonstrate a thorough understanding of course content, apply consistent and honest effort, and work effectively towards their own goals in the process. Success in this course will be determined by a healthy work ethic, attendance and presence in class, integration of key skills, and putting one's best foot forward.

# **Course Objectives**

- Acquire basic playing skills on violin, viola, cello, or bass.
- Understand the relationship between your playing, emotions, physicality, and decision-making.
- Develop diagnostic skills for teaching basic posture, position and performance in string playing.
- Survey and compare common string methods (methods books) to be able to confidently select an appropriate and effective approach for any given school program.
- Comprehend instructional content and sequencing for teaching a string program.

# Course Content, Readings, & Media

All content, readings, and media will be provided by the instructor. There are no required out-of-pocket costs required for students to take this course. Students are not required to purchase any books, equipment, or other materials for this course.

## **Grading Policy**

## Performance: 25% (100 points)

During the university scheduled final exam time, your class will put on a concert performance in a public area of the building. You will be responsible for learning and understanding all aspects of a classroom performance. All aspects of the final concert will be compiled into a google folder to which I will give you access for your records later in your teaching career.

# Participation: 25% (100 points)

Participation in class means actively engaging with the instruments, content, and fellow classmates. This portion of the grade also includes occasional readings, though these are relatively few. A participation grade will be given to every student following every class. Careful listening, skillful playing, physical and emotional self-awareness, and integrating skills and ideas as needed are key. Using a laptop, tablet, or mobile device for any purpose unrelated to the conversation or the course will be construed as a lack of participation.

## Teaching Demonstrations: 25% (100 points)

Each student will teach the class 8-minute lessons. Students will submit a lesson plan for each 8-minute lesson to be approved by the instructor prior to the teaching demonstration. After the teaching demonstration, students will also submit a reflection assessing their own teaching in comparison to the lesson plan that they wrote. The teaching demonstration grade will consist of a combination of the lesson plan, the teaching demonstration, the student reflection, and an evaluation by the course instructor.

# Assignments, Reflections, and Discussions: 25% (100 points)

Students are expected to complete readings, quizzes, class or Canvas discussions and reflections as they are assigned.

\*\*\*\* Please note - students will need to refrain from using cell phones, smart watches, and other devices during class.

Laptops and tablets are permitted for class work only. Cell phones are not permitted unless requested from the instructor before the start of class. If it becomes evident that laptop/tablet usage is contributing to distractions (e.g., surfing the web, doing outside work), the instructor reserves the right to prohibit their future usage. Inappropriate use of these devices will result in lowering your grade by a letter.

## **Late Work Policy**

Deadlines are marked in Canvas as well as in the syllabus. I will accept late work at 5 points off per calendar day that it is late. Please communicate if you have extenuating circumstances.

# **Attendance Policy**

- Attendance at all class meetings is expected. Three absences for any reason (aside from university-excused absences) will subject the course grade to being lowered by one full letter. Per Division of Music Education policy, more than three absences result in a failing grade for the course. End-of-semester juries must not be scheduled during class time; any such absences will not be excused.
- Daily attendance will be taken by the instructor. All students are responsible for staying informed of inclass assignments, email or Canvas announcements, physical handouts, turning assignments in on time, and informing the instructor in writing (by email) of any circumstances affecting attendance or performance in class.
- Be on time. Three tardies equal one unexcused absence.

## Financial Aid and Satisfactory Academic Progress

#### Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

#### Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
