Course description

This course focuses on French grammar and intensive practice through various composition assignments and grammar exercises.

Course structure

This is a 3-credit course meets in person on Monday and Wednesday from 12 to 12:50 pm. Friday's class is online and asynchronous.

Course objectives

Upon successful completion of this course students should be able to:

- show their awareness and understanding of complex structures and grammatical elements of the French language;
- to identify and analyze grammatical features in a variety of texts in French;
- produce grammatically appropriate and accurate French language in context.

This course fulfills the ***CLASS requirement for Communication and Digital Skills***. At the end of this course, students should:

- be able to demonstrate effective communication using a digital technological platform and;
- do at least two of the following:
 1. Demonstrate the ability to communicate a central idea effectively using appropriate organization/structure;
 2. Demonstrate the ability to develop content at an advanced level using a combination of effective supporting materials;
 3. Demonstrate the ability to engage in verbal and nonverbal communication behaviors that are appropriate for the audience and adhere to the conventions of the medium selected (written, oral, or visual).

Prerequisites

Completion of FREN 2050 (or equivalent) is required for this course.

Grading Policies

Deadlines

Deadlines will be posted in Canvas and in the syllabus. Any changes will be communicated via Canvas announcements and new dates will be reflected in the activity/assessment deadline on Canvas.

Grade Disputes

You are required to wait 24 hours before contacting me to dispute a grade. Within that time, I expect that you will review the assignment details and reflect on the quality of the work you turned in. If you would still like to meet, email me to set up a meeting (I cannot discuss grades over email). You should come to our scheduled meeting with specific examples that demonstrate that you earned a higher grade than you received. If you miss your scheduled meeting, you forfeit your right to a grade dispute. If you do not contact me to schedule a meeting within seven days of receiving your grade, you also forfeit your right to a grade dispute.

Attendance & Participation:

Class attendance is mandatory. Missing class meetings—or part(s) of class (repeatedly arriving late/leaving earlier)—will result in loss of points in the attendance category (as calculated by Canvas based on the total number of attended classes). Students will automatically receive a grade of zero (for the entire semester) in Attendance & Participation after eight (8) unexcused absences.

Authorized absences as listed in the UNT policies will be excused and will not affect students grade as long as students contact the instructor with appropriate documentation immediately upon their return and complete any missed/make-up assignments. Your participation will be graded each class meeting (up to 5 pts for a total of 10 weekly points). It will be based on the following factors (see table below), which will also tie in with daily activities and homework:

- **oral performance:** tying in with the next two categories, students will also be assessed on their use (and quality) of French during class.
- **active participation:** student volunteers to answer questions, provides answers to exercises, facilitates group discussion or pairwork, keeps group on task, etc.
- **preparation:** student comes to class prepared (with their materials) and ready to work. Student completes all preparatory tasks before coming to class (reading and homework).
- **cooperative behavior:** student pays attention, displays positivity, leads, supports and mediates during group/pair activities.

Oral performance	Participation, preparation & behavior	Possible Pts
Excellent	Uses only French when possible; always volunteers to participate; offers relevant comments; demonstrates extensive preparation; stays on tasks; and exhibits excellent, cooperative behavior.	5 pts.
Good to very good	Uses French often and offers relevant comments; often volunteers to participate; demonstrates a good degree of preparation and stays on task; and exhibits good, cooperative behavior.	4 pts.
Needs more work	Uses French and English; comments are sometimes off topic; average participation (needs prompting); adequate preparation (but sometimes inconsistent); generally, exhibits good, cooperative behavior.	3 pts.
Less than satisfying	Frequent use of English; rarely participate voluntarily; inconsistent preparation and/or does not stay on task (is distracted or distracts group) and/or unproductive behavior.	1-2 pts.
Unsatisfactory	Present in class, yet does not participate, and/or exhibits disruptive or negative behavior. Absent from class.	0 pt.

Homework & In-Class Activities

Students will be expected to complete various assignments at home or in class throughout the semester. In addition to completing textbook activities (which may or may not be graded), students will be responsible for submitting exercises on Canvas (due Friday night—for the online asynchronous portion of the course) or turn them in class (details will be provided by the instructor).

Quizzes & Exams

Throughout the semester, students will complete different types of assessments, including short quizzes and exams. Short quizzes may or may not be announced: they will be completed in class and will cover a specific grammar point or chapter. Exams will be done on Canvas and will cover more extensive materials (several chapters at the same time): they will be timed to ensure preparation from students and prevent cheating.

Compositions

Two compositions will be assigned during the semester. Instructions and grading criteria will be provided on Canvas. Students will submit a revised version of their compositions after they receive the instructor's feedback.
