BUSINESS FRENCH - FREN 4080 Fall 2017

Course Objectives

The objective of this course is to enable students to become functional in a French-speaking business environment while providing opportunities to learn new vocabulary and further develop the four language skills (reading, writing, listening, and speaking). There is no prerequisite course in Business but FREN 2050 is a minimum requirement (preferably additional advanced coursework in French).

Course Content and Description

Course meets Tuesday/Thursday from 12:30 pm to 1:50 pm (3SCH), in LANG 114.

Students will learn the basic vocabulary and cultural habits necessary to work in a Frenchspeaking country.

Topics will include: professional interaction and communication, customer service and client relations, job search and employment, major functions and departments within a company, social issues, advertising, purchasing and sales, transportation, attending professional meetings and conventions, among others. Multimedia resources will complement lectures and readings. This class will be conducted in French, and all readings and assignments will be in French.

Attendance

Class attendance is mandatory. Students missing class--or part(s) of class, i.e. repeatedly arriving late/leaving earlier--will be penalized. Specifically, students will be allowed two (2) unexcused absences during the semester. After they have used these two "free passes", students will start losing 2 % of their overall grade for each additional unexcused absence. Students will automatically be dropped from the class with a grade of WF after 8 unexcused absences.

Participation

Students will be graded on the following:

- **active participation**: student volunteers to answer questions, provides answers to exercises, facilitates group discussion, keeps group on task, etc.
- **preparation**: student reads the material before coming to class and completes the daily homework assignments. After each *"étape/module"*, students will have to complete the exercises on the corresponding pages of the *"Cahier d'activités"* before the following class.
- **cooperative behavior**: student pays attention, displays positivity, leads, supports and mediates during group/pair activities.

The rubric below will be used:

Uses only French when possible; always volunteers to participate; always comes to class prepared; and exhibits excellent, cooperative behavior	5 pts.
Uses French often; often volunteers to participate; usually prepared for class; and exhibits good, cooperative behavior;	4 pts.
Uses French but average participation; adequate preparation; generally exhibits good, cooperative behavior	3 pts.
Frequent use of English; participate mostly if prompted; and/or unproductive behavior (even with adequate preparation)	2 pts.
Present in class, more English than French, minimal participation; and/or uncooperative and/or unprepared	
Present in class, yet does not participate, and/or exhibits disruptive or negative behavior. Absent from class.	0 pt.

Exams

There will be three (3) exams of equal value in the course of the semester. They will cover all materials presented in class and assignments.

Homework assignments

In addition to daily exercises (completion counts towards participation), students will turn in six (6) written homework assignments throughout the semester; Assignments may include textbook exercises or other activities and will be posted on Blackboard. The lowest grade will be dropped.

Portfolio

As a final project, students will prepare an advertising campaign for a product of their choice and submit a portfolio to the instructor. Directions on the content of the portfolio will be provided at a later date. Students will present their advertisement campaign in class.
