- **Course description and objectives:** This "special problem" course focuses on the current state of the France and will include analysis of current events, the political system and projected data for 2015. It is based on independent study, but the student is expected to submit assignments and meet with the instructor on a regular basis.

By the end of the course the student should:

- have improved his understanding of written and oral material in authentic language;

- have further developed his critical thinking, in particular with regards to current political events and their impact on the global scene;

- have a better understanding of the French culture (including economy, political system, etc).

- **Reports:** Every week the student will be required to write a summary and commentary of a relevant source (including, but not limited to video clips, news broadcast, online articles). The student will be responsible for finding the appropriate and relevant material online. However, some material may also be assigned by the instructor in the form of a topic, file or link via Blackboard. Information/instructions about the report format will be posted on Blackboard.
- **Online Discussions/comments:** Every week the student will be expected to engage in an authentic discussion based on the topic he has chosen to cover that week. This homework can be in the form of comments on French discussions forums, reactions posts to online articles, etc.

The student will have to take a screen shot of the discussion (or copy and paste it into a MS Word document) and submit the document along with the report on Blackboard. The grade will be based on the student's effort to participate in discussions with native speakers through personal comments, questions, or reactions to other people's comments/opinions.

- **Questionnaires:** Every three weeks the student will be asked to complete a questionnaire on the assigned reading material (book chapters, etc). Questionnaires will be available online (via Backboard), and student is expected to submit his answers through Backboard.
- **Essays:** The student will have to write three essays of equal length throughout the semester. Topics will be announced via Blackboard.
- **Oral face-to-face discussions:** Every two weeks the student will meet with the instructor for one hour to discuss his progress and the material he learned. Discussions will be conducted in French and graded based on the use of French (quality, accuracy, fluency) and knowledge of the material.
- **Missed meeting:** If the student is absent for a scheduled meeting due to illness, hospitalization, or other authorized emergency/activity, he must contact the instructor <u>immediately</u> and with <u>the proper documentation</u> (doctor's note, service bulletin, etc). Any other unexcused missed scheduled meeting will result in a loss points (2% of total grade for each missed meeting).
- Late or missed work: Unless student has a valid excuse (see reasons stated in the "missed meeting" section above), missed work will result in a grade of zero. A penalty will be given for late submission of work until three days past the deadline (after which the student will receive a zero). Penalty will be a 10% deduction for each day late.
