Course Description

This course is specifically designed for students in French, German, and Spanish who anticipate teaching in the future. Classroom meetings and Canvas work will include reading assignments and practical tasks such as planning sample lessons and evaluating/preparing different types of assessment tools. Students will be introduced to professional journals and resources as well as professional organizations, many of which offer a range of opportunities for professional development.

Course Objectives

This course serves as an introduction to theoretical foundations of language learning and best practices for language teaching with a specific focus on the following dimensions of foreign language education: 1) curriculum/program design; 2) teaching/learning; and 3) assessment.

Presentations 1 and 2 will be prepared and given in small groups, which is why regularly scheduled meeting times have been set aside for each group to meet. You may meet outside of class as long as every member of your group is able and willing to do so, but please do not put pressure on someone to meet outside of class since time is set aside for this. Presentation 3 is an individual presentation, which means that you will have less time for this presentation (only 15 minutes maximum). Instructions and an evaluation rubric will be provided in Canvas.
