I anticipate being able to provide feedback and grades for assignments within 3-5 days, excluding weekends and holidays.

If you want to visit me during office hours, send a message at least 48 hours in advance so that I can arrange for us to meet in a well ventilated space that might end up being indoors or outdoors. Focus on French grammar and intensive practice through various composition assignments and grammar exercises.

Course Structure

This course is approved for a face-to-face format. FREN 3070 is not approved as an Internet course. Throughout the semester, we will use Canvas as a communication tool and as a way for you to submit assignments and receive feedback and grades. However, this course will not be recorded or streamed live because this course is not approved as an Internet course. We will have in-class writing assignments this semester, and both of these assignments will be completed in the classroom during our regular meeting times on October 7, 2021 and November 23, 2021. Teaching Philosophy

This course is designed for students who are engaged in the learning process. I will do my best to motivate you, but I cannot instill in you a sense of motivation and responsibility since those are things that only you yourself can develop as part of your own approach to learning. Try to keep things simple. Read the syllabus, come to class, do your work, and go beyond the basic assignment each time by trying to learn a little extra here and there. If you do some work every day or almost every day, you can avoid having to rush and cover too much information right before something is due.

Course Requirements

There are three different types of assignments in this course:

1) Grammar and Translation Project (GTP) – You will have 12 of these, each one is worth a maximum of 50 points. Whenever a class meeting date is designated as a GTP, we will not meet as a group in the classroom. You can work on the GTP at home, in a library, or wherever you decide to work.

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:
