Student Learning Outcomes

- Identify important geographic information related to francophone areas of the world
- Summarize major agricultural/industrial information regarding francophone countries
- Analyze francophone music from different perspectives
- Use francophone music as a pedagogical tool
- Analyze francophone cinema from different perspectives
- Use francophone cinema as a pedagogical tool

N.B. Although the term *francophone* is sometimes used to refer to places/people outside of France, we will use the term as a label for all places where (including France) and all people for whom (including people in France) French is a national, native, and/or official language. Nonetheless, for the purpose of this course we will focus on cinema and music outside of France or cinema/music produced by people who immigrated to France (or whose families immigrated to France). The only reason for choosing this focus is to allow students to explore cinema/music beyond the typical films and songs presented to learners in French textbooks.

Monday, June 18 – Overview of the francophone world: geography, history, politics

Tuesday, June 19 – Film vocabulary; Film as a pedagogical tool

Wednesday, June 20—Presentation 1

(cinematic production in 1 area of the francophone world)

Thursday, June 21—Independent work on Presentation 2 (no classroom meeting)

Friday, June 22—Presentation 2 (one film): brief biography of one or more actors with a major role in the film and/or the director; overview of the plot; one or two important scenes; pedagogical application(s)

WEEK 2

Monday, June 25—Independent work on Presentation 3 (no classroom meeting)

Tuesday, June 26—Presentation 3 (one singer): brief biography; overview of career; 2 or 3 most famous and/or most important songs; pedagogical application(s)

Wednesday, June 27— Overview of francophone music and the vocabulary of music

Thursday, June 28—Independent work on Presentation 4 (no classroom meeting

Friday, June 29—Presentation 4 (one singer): brief biography; overview of career; 2 or 3 most famous and/or most important songs; pedagogical application(s)

INDEPENDENT RESEARCH

Each student will prepare a research report between June 30, 2018 and August 1, 2018.

- This project will be in the same format as the comprehensive exams (5-7 pages plus references, double-spaced lines, 1" margins on all sides, 12-point font).
- The research report must be submitted through Canvas by midnight (local time) on August 1, 2018.
- Specific guidelines will be provided in Canvas. There will be two main parts:
 1) Brief overview of a film (including cultural and linguistic aspects that are interesting, strange, important, or noteworthy) and
 - 2) Possible pedagogical applications based on the World-Readiness Standards for Learning Languages (American Council on the Teaching of Foreign Languages, 2015).
