Course Description

Exploration and analysis of cultural, historical, political and social dimensions of language use, language contact, and multilingualism in a range of linguistic landscapes around the globe.

This course is taught in English. Nonetheless, we will explore various types of linguistic landscape artifacts that are written/designed in other languages.

Course Structure

This is a completely online course. There are no on-campus meetings. Each module will typically include required readings, an optional Zoom meeting, and at least one major assignment.

There will be an optional Zoom meeting on Monday of Week 2, Week 3, Week 4, and Week 5. Students who do not attend this optional Zoom meeting can watch a recording of it. **Students can decide** whether or not to turn on the camera. The majority of the meeting will involve the instructor sharing his screen and explaining linguistic landscape artifacts (photos or scanned images). Students can ask questions during the Zoom meeting; students can also use the Week 2, Week 3, Week 4, and/or Week 5 Discussion board to ask/answer questions and make comments.

This optional Zoom meeting will be recorded so that students who do not attend the live meeting can watch it at their convenience. This recording is intended only for students in this course, and it is only intended for use in this course. The recording will be deleted when this course ends, and it will not be used again for any purpose.

Course Prerequisites or Other Restrictions

There are no prerequisites for this course.

Course Objectives

By the end of this course, students will be able to:

- 1. Evaluate and illustrate how language can shape the human condition and human experiences.
- 2. Identify key features of linguistic landscape artifacts.
- 3. Compare linguistic landscapes in similar and dissimilar contexts.
- 4. Collect and organize linguistic landscape artifacts.
- 5. Locate and evaluate relevant research resources/materials.

Articles will be read in their entirety, with one exception—the autoethnography text (**Chapter 4 only**). Supplemental audio, visual, and audiovisual files will be used from online sources. Teaching Philosophy

There are various models of instruction. You may be familiar with the "sage on the stage" approach, which is when students listen to an expert talk about all sorts of things that are more or less relevant to the topics being covered in a course. This is a traditional approach that is often used in face-to-face classrooms (or even on line), especially in large lecture classes. Basically, there is someone talking, and you take notes, then you have an exam, and then the cycle begins again.

Instead of using a traditional approach, this Internet course requires you to "take charge" of your learning and stay current with the assignments. In order to provide students with a self-paced format, you need to accept responsibility for doing the work on time, which means being organized.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit,

cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.
