Course Description

Spanish 3001 is an advanced conversation course for non-native speakers of Spanish who have successfully completed SPAN 2050 or its equivalent. This course will be conducted entirely in Spanish and it will expand your vocabulary and improve your ability to read, comprehend, listen, and discuss a broad variety of topics in Spanish. Upon completion of this course, students will be able to discuss events, present detailed arguments, and summarize information at a level appropriate to advanced Spanish speakers.

Course Structure

All classes will be delivered in the classroom. Study assignments are organized in **6-unit lessons** based in the textbook. Each unit lasts 2 weeks. Exam study guides, assignments guide and grading rubrics are available in Canvas.

Course Prerequisites or Other Restrictions

This course is designed for students who have passed Spanish 2050 at UNT or the equivalent. Do not enroll in this course if you have not taken the pre-requisites. For more information, please contact the Department of Spanish in LANG 101, (940) 565-2404.

Course Objectives

By the end of this course, students will be able to:

- 1. Acquire oral proficiency appropriate to advanced language acquisition.
- 2. Summarize information, present arguments, persuade, analyze, and interpret the opinions of others at a level appropriate to advanced language acquisition.
- 3. Attain vocabulary and grammar necessary to support and facilitate in-depth conversation and expression of opinions at a level appropriate to advanced language acquisition.
- 4. Discuss knowledgeably about the assigned readings, videoclips, and contribute to the topical discussions.
- 5. Recognize cultural awareness of the Spanish-speaking world appropriate to advanced language acquisition.

Grades will be rounded up to the next grade (e.g., 89.5-89.9= 90)

To be successful in the next level of Spanish, it is highly recommended that students pass this course with a final grade of C or above. A minimum grade of C is obligatory for all Spanish majors and minors.

Class Participation

Participation is a vital part of any language learning experience. Your careful preparation prior to attending class and your sustained participation will determine your success. To improve your level of participation and maximize your use of class time, prepare thoroughly prior to each class. This may require multiple readings of the reading assignments. This course is student-centered and relies heavily on your interaction and collaboration with your peers. Much of your work during class will be completed in pairs and groups, with your instructor as the facilitator and you and your classmates as the main participants. All students are expected to participate equally in these activities and will be graded accordingly. Participation points will be posted in Canvas monthly. Although attendance is mandatory, be mindful that attendance without active and sustained participation, does not guarantee a good participation grade.

You can earn up to 5 participation points per class as follows:

- attending class and arriving on time (1 pt.)
- being well prepared for all oral activities and using only Spanish during class (1 pt.)
- making a significant contribution by listening and participating in discussions (1 pt.)
- listening to and responding to differing opinions with courtesy (1 pt.)
- staying on task during class (1 pt.)

Homework

Homework will be assigned for each class. This will involve readings (students must read the indicated pages for each day given on the syllabus before coming to class), viewing video clips, and preparation for in-class oral activities. Supersite, the online component of the course, will be used for part of the homework. Supersite assignments will be due **by 12:00 pm before class**. To access the *Supersite*, you must create an account. If you already have an account, you log in and find your Spanish course. www.vhlcentral.com

Quizzes

At the end of each lesson, there will be a quiz to evaluate your knowledge in grammar and the assigned readings. It is highly recommended to take good notes from each reading. Quizzes will taken in in Canvas using LockDown Browser, a proctoring system provided by UNT. Quizzes will be based on the homework and material covered in class. There are no makeups for missed quizzes due to absences or tardiness.

Oral Presentations and Peer Review

Students will complete two oral presentations on the dates assigned in the assignments schedule calendar. The presentations will be given during class time and will focus on a topic related to the themes, conversations, and grammar covered in the textbook. The presentations must not be read and must meet the time requirements (between 3-4 minutes). If using a PowerPoint presentation, the information should be in bullet points and no more than 25 words in Spanish per slide. Presentations will be Peer Reviewed. The grading rubrics for assessment of oral presentation and any additional instructions will be posted to Canvas. Students will be graded on their 1) organization, 2) content, 3) grammar, 4) pronunciation, and 5) fluidity.

Video Journals

Each student will record a total of 4 video journals that address a different topic assigned from the chapters studied within the semester. Videos must be **3 minutes in length** and must be turned in according to the directions of the instructor. Videos will be graded on their **1**) organization, **2**) content, **3**) grammar, **4**) pronunciation, and **5**) fluidity.

After you upload your video journal, you must watch two video journals posted by your classmates and provide constructive criticism and feedback on each one of them. "Muy bien" or "Me gustó mucho" are not constructive comments. You can also comment on grammar, pronunciation and / or content issues.

To receive **4 extra points** in each journal:

- Post your video at least two days before the due date
- Watch the videos of two classmates and give one meaningful comment each (see instructions below)

Your video and 2 comments must meet the time and length required

Midterm Exam

Midterm exam will be oral. Students will engage in a **4 to 5 minutes** paired conversation. A random draw on the day of the exam will determine the topic of the conversation. The choices will be based on the topics covered up to the date of the midterm exam. Conversations will be graded on their 1) content, 2) grammar, 3) vocabulary, 4) pronunciation, and 5) fluidity. Instructions, topics and grading rubric will be available in Canvas.

Final Exam

Students will engage in a **5 to 7 minutes** paired conversation. A random draw on the day of the exam will determine the topic of this conversation. The choices will be based on the topics covered throughout the semester. Conversations will be graded on their 1) content, 2) grammar, 3) vocabulary, 4) pronunciation, and 5) fluidity. Instructions, topics and grading rubric will be available in Canvas.

Lockdown Browser System

Quizzes will be taking using LockDown Browser System. Instructions and the link to download the application in your computer is in "Where to get help" Module in Canvas. To take quizzes you will need a webcam on your computer. If your computer does not have a webcam, you can take the quiz in the Language Lab, the Library or other buildings in campus. Check their schedule or call them in advance.

Course Evaluation

Student Perceptions of Teaching (SPOT) is the student evaluation system for UNT and allows students the ability to confidentially provide constructive feedback to their instructor and department to improve the quality of student experiences in the course. Students will receive 10 extra points in the participation category for doing your SPOT evaluation. Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.
