Course Description

This is a hybrid course (online and face-to-face) that emphasizes basic conversation skills in Spanish for those serving or interested in the law enforcement field. Students will learn specialized vocabulary, scenarios, sample dialogues and information on the Hispanic culture related to law enforcement from a cross-cultural perspective.

Course Objectives

By the end of this course, students will be able to:

In class:

- practice typical everyday situations specific to law enforcement
- Dramatize specific roles on scenarios specific to law enforcement
- Recognize active words and expressions presented in dialogues specific to law enforcement
- Recall practical vocabulary, every day on-the-job situations, and culture notes
- Apply grammatical concepts in a wide variety of practical contexts related to police stations, prisons and on the street
- Formulate needed information related to selected scenarios
- Demonstrate the ability to appropriately construct and respond general questions, statements and commands in Spanish

Online:

- Identify vocabulary, active words and expressions related to law enforcement situations
- Interpret short reading sections related to law enforcement

- Practice grammatical structures in preparation for face-to-face class
- Comprehend a variety of dialogues presented through videos and audios
- Investigate the law enforcement system of a variety of Hispanic countries

Course Content

This course will cover lessons 1-10 of the textbook and the content is available in the course schedule. It is your responsibility to consult the class schedule and meet the deadlines for all assignments. To keep up with the course, it is highly recommended to work in iLrn assignments every day. All assignments are due every Friday,

Delivery of Content

Online work:

The purpose of this course is for students to practice their Spanish speaking skills in the classroom, therefore, each student will be in charge of studying the grammatical concepts and vocabulary at home using the textbook and iLrn homework. There will be several weekly assignments to do online using the iLrn website. It is highly recommended to watch the grammar videos and do the homework assignments before taking the quiz.

In class: students will use the grammatical concepts and vocabulary learned at home to work in pairs or groups to practice scenarios and situations related to law enforcement. Students are expected to come prepared to the classroom with the assignments listed in the course schedule and ready to practice.

Course Requirements

Active Participation:

Class participation is a vital component to the language learning process. Your level of participation and preparation will be evaluated each class, and you will receive an average score at the end of each month during the semester. This grade will be based on the following: attendance/punctuality, preparation for class, level of engagement, and use of Spanish. The following rubric applies to the class:

Class Attendance:

Class attendance is mandatory and essential to your success in learning Spanish. No make-up work will be allowed for unexcused absences. Only those individuals whose absences are authorized by the instructor will be eligible to make up any material missed. Excused absences include the following: illnesses, deaths in the family, religious holidays, and university sponsored activities. For illnesses and deaths, you must provide documentation (physician's statement, obituary, etc.) **the first day you return to class** in order to be excused. Absences in observance of religious holidays are authorized only if you have notified your instructor in writing within the first **15 days** of the semester. For university sponsored activities, you must obtain authorized absence cards from the Dean of Students and present them to your instructor in order for your absences to be excused. Since we only have one meeting per week, after the **4th** unexcused absence you may be dropped from the course.

iLrn Online Homework

Using iLrn (textbook website), you will be assigned a variety of grammar, vocabulary, reading, writing and listening activities. iLrn assignments are due every <u>Friday 5:00 pm</u>. **Late work is not permitted.**

Ouizzes

There will be quizzes throughout the semester that will evaluate your knowledge on vocabulary, listening, and specific grammar points for each lesson of the textbook. All quizzes will be taken in your computer at home or in the Language Lab using the LockDown Browser System. Quizzes will be due every Friday, 5:00 pm. It is highly recommended to finish with all your weekly iLrn homewok and watch all grammar videos before taking quizzes.

Midterm Exam

Midterm exam will be taken in the Language Lab using the LockDown Browser System and it will assess your Spanish listening, writing and reading skills. It will include vocabulary and grammar structures learned in lessons 1-5. Plan your schedule accordingly. There are no make ups for the Midterm exam.

Final Exam

Final Exam will be taken at home or in the Language Lab using the LockDown Browser System. The final exam will take **two hours** and it will assess your Spanish listening, writing and reading skills. It will include vocabulary and grammar structures learned in lessons 6-10. Plan your schedule accordingly. There are no make ups for the final exam.

Research assignment:

Using a minimum of 3 trusted articles or websites as resources of research for the topic of choice, students will write a 2-3-page paper in Spanish. The topic must be related to law enforcement in a Hispanic country that shows how the system works in other countries in comparison with the United States. The paper should be well organized with an introduction, body and conclusion and it must include a Work Cited list of the resources used. The paper will be submitted in the place assigned in Canvas before the due date.

Oral presentations

At the end of the semester, students will do a 5-minute Power Point presentation to the class that summarizes their findings on their research topic. During each presentation students will write an evaluation and comments of their classmate's presentation. At the end of class students will turn in their evaluations (for a grade). There are no make ups for presentations or peer evaluation for missing class. More information provided in Canvas.

Course Policies

On outside help/academic integrity

Cheating hurts everyone. Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website at http://www.ecfr.gov/. The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer

transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.
