Course Description

Fundamental concepts and properties of fluids. Hydrostatics. Basic equations of fluid flow in differential and integral form. Dimensional analysis, potential and viscous flow. Viscous boundary layers, pipe flow, turbulence, and fluid flow correlations for objects of simple shape.

Course Structure

Lectures are asynchronous remotely delivered via video recordings taken in Zoom and available through CANVAS. Recitation sessions are available during course meetings times. Exams also taken during course meeting times and facilitated via CANVAS / Respondus lock down browser.

Course Prerequisites or Other Restrictions:

NOT be pre-engineering major. Pass with C or better:

3. MEEN 2210: Thermodynamics 1. Zeroth, first and second laws of thermodynamics with applications to engineering and energy conversion, open and closed systems, thermodynamic properties of simple substances, equations of state, thermodynamic properties of mixtures, psychrometrics and psychrometric charts
4. MEEN 2332: Mechanics III. Basic concepts of stress and strains. The influence of loading direction and location on the deformation of structures. Understand the impact of loads on designs. Understand failure criteria for designs.[Course Objectives:](#)

This course addresses following ABET program outcomes:

1. apply math (vector calculus & differential equations) and fundamental science (conservation of mass, momentum) to fluid mechanics problems
2. Identify engineering problems & use basic laws of fluid mechanics to solve them
3. Draw free-body diagram of fluid statics problem, convert pressure distribution to resultant force, and solve for unknown forces
4. Use Moody diagram to find friction factor and solve for pressure drop due to friction
5. Understand and apply Bernoulli's equation
6. Find the total acceleration of a fluid particle
7. Be familiar with the derivation of the Navier-Stokes equations

8. dimensionless groups from list of variables using Buckingham Pi theorem

Course Structure

Lecture modules are recorded in advance and available to view through canvas assignments on a regular schedule. Lectures include solved problems. Home practice questions are then available to work on. Review lecture videos as often as needed to complete home practice. Class time is for recitation problem solving with the teaching assistant to help answer any student questions. Instructor available most anytime via appointment. Connect to CANVAS to take exams using Respondus lock down browser software. Complete exams on-line during class time. Class attendance not graded. Quizzes are 6/16, 6/30, 7/14, and 7/28 during class time. Final exam is 5 August.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-

campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.
