COURSE DESCRIPTION: 3 hours. Students conduct an in-depth investigation of a research methodology used by art education and education researchers, including epistemological, methodological, and ethical issues and debates that surround it. Prerequisite(s): AEAH 5787.

READINGS: Readings are available on course Blackboard site or through UNT Library online resources.

COURSE GOALS and **OBJECTIVES**: This course will introduce students to arts-based research—currently associated with the field of art education. This form of research encompasses systematic inquiry created for, about, through, and/or as art intended to enhance, problematize, deepen, and/or complexify knowledge and practice related to art and pedagogy. The primary objective of the course is to prepare students to do forms of arts based research in varied contexts including schools, studios, communities, everyday life, museums, institutions, and other contexts. As we consider the intersections between art and research, we will concurrently examine the utility of these methodologies for the practices of visual arts educators, artists, and related professions. Students will apply theory to practice through the creation of a research project proposal utilizing one or a combination of associated methodologies as well as a mini-research project using Photovoice throughout the term.

STUDENT EVALUATION & ASSIGNMENTS: Evidence of progress will be assessed through the following:

<u>Class Participation</u>: Worth 10% of final grade. I will be assessing your performance based on the following aspects of quality participation:

- 1. actively participating in class discussions, simulations, and activities—seeking challenges, persisting, and reflecting,
- 2. offering thoughtful insights which demonstrate knowledge of course readings,
- 3. respectfully responding to course members' perspectives,
- 4. concentrating on classroom activities.

Readings Presentation/Discussion: See handout for details. 1-2 student facilitations per week over course of semester. Photovoice Explorations: As a way to gain experience with practice-based research, we will explore the methodology of Photovoice in relation to our practices. Throughout the term, we will take photos in response to the prompt research, then share, analyze, and discuss our ongoing explorations with Photovoice (expect to be taking photos, bringing them to class, and sharing your related ideas {keeping a research notebook to trace your thoughts is recommended} every two weeks for 3 cycles). This project can be integrated into your final proposal or not. It may reflect the contexts of research, processes of inquiry, hard data collection within your project, data analysis, a metaphoric imaging of the topic, or another approved idea you come up with. Proposal: Due Dec. 10. Proposal workshops during class Nov. 8 and 15. Applying theory to practice, use the class readings and discussions as a starting point to select a topic related to a practice with personal relevancy. This final proposal must include examples of some activities and/or creative works that would be a part (or starting points) of the research. Please use the most recent version of the Publication Manual of the American Psychological Association (see APA Quick Guide on our Blackboard site). The assignment is broken down into the following parts that will act as your required headings:

Research question(s)

Review of previous research (connected to the methodology of your choice)

Methodology(ies) & Procedures

Significance of your research & Implications for art/design/museum education

Annotated Bibliography: Due Nov. 1. Choose and creatively present 10 resources that ground your proposed investigation. *Resources* is very broadly defined, but the final bibliography must be submitted as a word docx.

<u>Proposal Presentation</u>: Presented on Nov. 29 or Dec. 6. Each student will prepare a brief oral presentation through which the class will be familiarized with the chosen topic. PowerPoint and handout of slides should be used to support the presentation. **Grades will be broken down as follows:**

Class Participation (including questions for readings) 10%
Photovoice Explorations 20%
Readings Presentation / Discussion 20%
Presentation of Proposal 10%

Choose how you want the last 40% broken down between 2 assignments, with 10% as a min. and 30% as a max. for either assignment.

GRADING: An A grade will be 90% or above, B = 80-89%, C = 70-79%, D = 60-69%, and below 60% an F.

You are responsible for all material assigned and covered as part of this course.
