Course Description

Study of basic concepts of accident prevention, safety education economic impact and environmental hazard control. Includes OSHA regulations and other regulations as they relate to the employer, the employee, and the public.

Course Objectives

By the end of this course, students will be able to:

1. Describe OSHA basic mandatory procedures, training, and records.
2. Enumerate and describe major aspects of construction project site safety.
3. Identify primary types of accidents on the job sites.
4. Identify the types and severity of penalties imposed on violators.
5. Apply safety economics.
6. Apply requirements for compliance and inspection imposed for the safety of construction sites.
7. Apply fundamental safe practices and decisions commonly implemented on construction sites.

8. Develop a company project site safety plan. **(ACCE SLO #1 & SLO #3)**

Individual Assignments

A student is required to complete an assignment related to the topic/s presented in class. Assignments may be given in class. Completed assignments must be submitted to **CANVAS ONLY** on the due date specified in the course

Quizzes

Quizzes will be given on **ANY of the meeting days (i.e. either on Tuesday or Thursday)** during the week which covers topics presented in class. Quizzes can be in the form of objective questions such as multiple choice or essay, calculations, drawing and labeling and case studies/ analysis.

Exams

Exams are major assessments of students' understanding of the course. Exam usually covers multiple chapters/ lessons covered in class. Exams can be a combination of multiple choice, true or false, calculation or analysis and essay.

Final Individual Project

Each student must submit a final term project of a construction safety plan. This individual student term project applies the knowledge and fundamental principles of construction safety and OSHA standard learned in the course. The project must be uploaded in Canvas as pdf file on the due date specified. No late submission is allowed, no exception. See separate information document on project.

Class Exercises:

- There will be exercises that will be completed individually or in a group. For group exercises, each student will be assigned to a group, and the group will remain together for the rest of the semester.
 - Groups will be selected at random to present the results of their exercises to the rest of the class.
 - All members of a group who work on the exercises and participate in the presentations will receive the same grade.
 - Students who do not work on any specific exercises will receive a grade of zero.
 - Students who do not participate in the presentations but worked on the assignments will receive 50% of the exercises grade.
 - Only the names of students who worked on the specific group exercise shall be listed in the report.
- Specific instructions will be provided for each group exercise.
- All reports shall be submitted via CANVAS.
- Any work submitted after the deadline shall receive a grade of zero.
- Reports shall be typed and prepared professionally.

My approach to teaching this course involves a combination of lectures, group presentations by students, class discussions, assignments, tests, and exams. Important Notice for F-1 Students taking Distance Education Courses Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an

on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

Student Verification

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for

students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.
