Communication Expectations:

Course Description

Planning, organizing, scheduling, and managing construction projects. Includes preconstruction planning, cost and quality control, materials procurement, subcontractor management, start-up, and close-out.

Course Objectives

By the end of this course, students will be able to:

1. Describe the need for and nature of management structure in the construction industry.
2. Understand basic construction-based company structure with the consideration of project-level and strategic planning, contractual responsibilities, and risk. (*ACCE SLO# 10*)
3. Determine the impacts of schedule management and economic considerations on individual projects and companies. (*ACCE SLO##5, SLO # 11, ACCE SLO#13*)
4. Manage the selection, retention, and use of equipment and labor by a construction company.

Quizzes

Extra Credit:

Assignment Policy and Requirements

1. There are 10 graded Assignments with 50 points each.
2. All assignments are due at the end of the class period on the date given by the instructor, unless otherwise specified.
3. Any assignment and/or class exercise turned in late will be given a grade of zero.
4. Assignments shall be completed individually.

5. All assignments shall be submitted via CANVAS on the due date specified.
6. Any assignment submitted after the deadline shall receive a grade of zero.
7. All assignments shall be prepared professionally using MS Word or legible handwritten. Assignments can be submitted in pdf format.

The official due dates for assignments are as shown under “Course Structure”. Additional instructions will be posted in CANVAS under the assignment link. File type assignments should be saved in .DOC or DPF format. Files should be submitted via the Assignment drop box in Canvas on the due date specified.

Class Exercises:

- There will be exercises that will be completed individually or in a group in lieu of Assignment. For group exercises, each student will be assigned to a group and the group will remain together for the rest of the semester.
 - Groups will be selected at random to present the results of their exercises to the rest of the class.
 - All members of a group who work on the exercises and participate in the presentations will receive the same grade.
 - Students who do not work on any specific exercises will receive a grade of zero.
 - Students who do not participate in the presentations but worked on the assignments will receive 50% of the exercises grade.
 - Only the names of students who worked on the specific group exercise shall be listed in the report.
- Specific instructions will be provided for each group exercise.
- All reports shall be submitted via CANVAS.
- Any work submitted after the deadline shall receive a grade of zero.
- Reports shall be typed and prepared professionally.

Instructor Responsibilities and Feedback

My approach to teaching this course involves a combination of lectures, group exercises, class discussions, assignments, tests/quizzes, and exams. To succeed in this course, I recommend you spend a minimum of two hours studying the course material for each hour of the class lecture. To best benefit from the course, do not wait till the last minute before an assignment is due or the day of a test or exam to seek help. If you send questions via email, my goal is to respond within 48 hours. Therefore, use this as a guideline when you seek my help.

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website \(http://www.ecfr.gov/\)](http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.
