**Course Description**

Construction Management for Mechanical, Electrical and Plumbing (MEP) Systems. 3 hours. An investigation into the integrated approach of managing and scheduling the installation of MEP systems, including the study and analysis of the basic Mechanical, Electrical, and Plumbing components in construction and their relationships to the overall building. Prerequisite(s): CNET 2180.

1. Describe the engineering concepts and design of mechanical, electrical, and plumbing systems. **(ACCE SLO# 17)**
2. Develop a basic construction-based knowledge on mechanical and electrical calculations.
3. Determine the impacts of the growing complexity of design standards and regulations and rapid changes in new building technologies as relates to electrical, mechanical, and plumbing system. **(ACCE SLO #15)**
4. Identify various equipment and components of electrical, plumbing, heating, air conditioning and ventilation systems.

### Quizzes

Quizzes may be given on ANY of the meeting days during the week which cover topics presented in class. Quizzes can be in the form of objective questions such as multiple choice or essay, calculations, drawing and labeling and case studies/ analysis. There will be 10 quizzes required for this course.

### Exams

Exams are major assessments of students' understanding of the course. Exams usually cover multiple chapters/ lessons covered in class. Exams can be a combination of multiple choice, true or false, calculation or analysis and essay. There will be 3 major exams required for this course.

### Extra Credit:

- From time to time, with the discretion of the faculty, extra credit will be given in class in the form of seat work, group work etc.

### Class Exercises:

- There will be exercises that will be completed individually or in a group in lieu of Assignment. For group exercises, each student will be assigned to a group, and the group will remain together for the rest of the semester.
  - Groups will be selected at random to present the results of their exercises to the rest of the class.
  - All members of a group who work on the exercises and participate in the presentations will receive the same grade.
    - Students who do not work on any specific exercises will receive a grade of zero.
    - Students who do not participate in the presentations but worked on the assignments will receive 50% of the exercises grade.
    - Only the names of students who worked on the specific group exercise should be listed in the report.
- Specific instructions will be provided for each group exercise.
- All reports shall be submitted via CANVAS.
- Any work submitted after the deadline shall receive a grade of zero.
- Reports shall be typed and prepared professionally.

### **Federal Regulation**

An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, satellite, audio conferencing, or computer conferencing. If the F-1 student's course of

study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

### **University of North Texas Compliance**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.
