Course Purpose: The goal is to give students foundational knowledge of the most well-known Brazilian folkloric music styles. Through lectures, research, and live performances, students will gain a solid general understanding of the language. This new knowledge will enhance their abilities as listeners, performers, composers, arrangers, and music educators.

Attendance Policy:

1. Attendance is MANDATORY because all information and practical experience will be provided during class. More than two (2) absences will result in a lower final grade, decreasing by one letter grade for each absence.
2. Students must notify the instructor if they cannot attend, and this notification should be sent via text or email before the class. **The student will be responsible for the material covered in class during an absence.**
3. It is essential to arrive on time for class and rehearsals. Students who regularly arrive late without a valid reason will face penalties, including a reduction in their final grade.
4. **Concert and performance schedules are subject to sudden modifications. Dress rehearsals are anticipated to extend beyond three (3) hours, and it is advisable to refrain from scheduling other activities on the same day as the dress rehearsal or performance.**
5. **Failure to attend or participate in the semester's final concert, dress rehearsal, or any other public or private performance will lead to a failing grade.**

3. All class members must complete this task by the end of **week 1 (Wednesday, January 14, 2026).**
4. **The student is responsible for attending any unscheduled task, activity, or performance announced via chat service or UNT email.**

Performance Dress Code:

1. It is an absolute requirement that you wear white pants or white skirts (ladies only, please) to the ensemble's concerts and performances.
2. A special type of sports jersey has been chosen as the official performance outfit. Students will need to cover the cost, which is expected to be between \$25 and \$40. More details about the cost and how to get the jersey will be shared by week 4.
3. Sandals are not permitted for male performers. Suitable sports shoes are acceptable, and dress sandals are allowed for female performers.
4. **Please adhere to these requirements to prevent removal from the concert program and to avoid receiving a failing final grade.**

Rehearsal Room Use Policy:

1. After each rehearsal, all ensemble members are required to organize the room into a classroom setup, following the arrangement posted at the door. No one will be dismissed until the room is properly arranged.
2. **All ensemble members are responsible for storing equipment neatly inside the storage room and locking the door after use. The storage room door should remain closed at all times when not in use.**
3. Once all chores are completed, please check the room for any trash that can be disposed of in the garbage container as you leave.
4. The default status of doors in room Bain 101 is "locked" when not in use. All students in Performance, Jazz Studies, or Music Ed are responsible for making sure all doors are closed and locked when leaving.

Hearing Protection is Required for this Course:

Hearing protection is **MANDATORY** for every student registered. The [UNT Speech and Hearing Center](#) will provide a hearing test to every enrolled UNT student for a flat fee of \$25. In addition, "musician's ear plugs" can be purchased at the clinic for around \$200. The College of Music provides foam ear plugs at no charge; students can pick these up from the repair shop in the Music Annex, room 106.

Financial Aid and Satisfactory Academic Progress

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

Graduates

Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
