Course Purpose: To provide the student with fundamental concepts needed for drum set or Latin American percussion performance. The course will emphasize drum set or Latin American percussion instrumental practices and techniques over 13 weeks. During this time, explorations of history, music cultures, and the study of the masters will be covered as well. The information acquired by the student through the lessons, barrier material, audio/visual material, research, jury transcription, and consistent practice will provide the student with a strong foundation in the instrument and musical language.

Attendance Policy:

- 1. Since all information and practical experience will be given and presented at lesson time, attendance is MANDATORY.
- 2. Students should give notice if they cannot attend a lesson. Notify your instructor by making a **phone call, text, email, or placing a note on the door.**
- 3. Failure to notify your instructor will affect the final grade. Lessons missed by the student will not be made up unless excused by the instructor.
- 4. Lessons missed by the instructor will be made up at a time convenient for both.
- 5. The student will be allowed **one absence**; after that, **each absence lowers the final grade by a letter.**

6. *All applied students* (that means YOU!) are responsible for attending **Percussion Departmental** on **Fridays at 1 pm**. Failure to attend **will lower your final grade.**

The Friday Departmental is a great opportunity to experience great performances and support your fellow percussionist. It is an essential part of your musical education.

Friday Departamental Performace Credit

1. Jazz Studies Students Departmental Performance:

- You are required to do a departmental performance.
- The repertoire chosen needs to be related to the Drum set Latin Jazz Curriculum you are covering during your time in Prof. Aponte's Studio.
- The departmental performance piece needs to be **approved** by Prof. Aponte on your lesson time **prior to applying** for scheduling the performance.
- A coaching session with Prof. Aponte a **week prior to the performance** is required for final performance **approval**.

2. Non-Jazz Drum Set and Latin Percussion Students:

- You are not required to do a departmental performance on a Drum set or Latin Percussion. You still need a Departmental Performance Credit, but it should be done through your regular percussion studio.
- If you desire to perform in the Percussion departmental on Drum set or Latin Percussion, the repertoire chosen needs to be related to the Non-Jazz Drum set/Latin Percussion Curriculum you are covering during your time in Prof. Aponte's Studio.
- The departmental performance piece needs to be **approved** by Prof. Aponte on your lesson time **before applying**for scheduling the performance.
- A coaching session with Prof. Aponte a **week before the performance** is required for final performance **approval**.

- 4. If the contact information is not summitted by the due date, the student will be responsible for attending to an unscheduled activity, Instructor absence notifications, and makeup lessons that could arise during the semester.

Weekly Assignments and Barrier Information

Please follow the UNT Percussion Manual schedule regarding private applied percussion lessons. Lessons are divided into twelve (12) weekly assignments to aid individuals in pacing themselves throughout the semester. Independently of whatever's been discussed on lesson time, students must prepare the assigned barrier material before their scheduled lesson time. The assignments are arranged to allow ample time for preparation.

Jury Transcription:

The material for the transcriptions will be selected by week 3 (the chosen material should reflect the musical goals of the semester). The title, drummer, and source will be notified to the instructor at that time.

Revision and completion schedule:

Week 5: Present draft.

Week 8: 1st revision

Week 10: 2nd revision and playable (slow tempo)

Week 12: Turn in the complete final transcription. At this time, the transcription should be playable at tempo with recording.

1. The use of music notation programs like **Finale** or **Sibelius** is **required**. The presentational quality of the final transcription should reflect college-level scholarly work.

Masters Research Paper:

- 1. A drumming master should be selected by **week 3** (The chosen artist performing the solo transcription should work best). A basic research paper on the artist will be made using the format shown in **handout #2**, attached to the syllabus. The Paper will be turned in on **week 6**.
- 2. Only information from scholarly sources will be admitted (Text Books, Biographies, Dissertations, Periodicals, Documentaries, CD/LP cover reviews). Wikipedia is a good starting point for the search for information, but in some cases is not reliable scholarly documentation and will not be admitted as a bibliographic source.
- **3. Carousel 411** on the 4th Floor of Willis Library (A.K.A College of Music Library) holds many text resources available to assist you with the task. These resources will only be used in the library. I intend to make them available to all the studio members and to make my students familiar with all the resources accessible to them at our music library.

Also, meet your librarians. They are there to assist you in making your quest for knowledge an enjoyable one.

The Styles Performance

Test: (Performance and Music Ed. Only)

- 1. It is required to attempt the SPT in the 1st Semester of Non-Jazz Level III
- 2. It is the responsibility of the student to contact the players to be used on test day by week 3 and to organize regular rehearsal time during the semester (at least 4).
- 3. One Rehearsal Must be Video Taped for Review on Week 11.
- 4. The instructor will be auditing the last rehearsal during Lesson time on **week 12**, a week before the jury. **The student is responsible for notifying and coordinating with the performers for that event.**
- 5. The student will be responsible for having his o her performers on time a ready to perform at the time of the test. **Tardiness or no attendance by ensemble members will be reflected in the student test results.**
- 6. The student must follow and understand clearly the guidelines given in Handout #4, "Tunes and Guidelines for Drum Set Styles Performance."

It is the responsibility of the instructor to answer any questions that arise referring to the guidelines and procedures for the test. Please do not hesitate to inquire for advice or clarification about the information given.
