Course Purpose: To provide the student with a basic knowledge of the most commonly known Brazilian folkloric music styles. The information obtained by the student through the lectures, research, and live performances will give the student a strong general foundation of the language. The newly acquired knowledge will serve the student well in improving his/her musical abilities as a listener, performer, composer, arranger, and music educator.

Attendance Policy:

1. Since all information and practical experience will be given and presented in class, attendance is **MANDATORY**. **Any more than two (2) absences will lower the final grade, one letter grade per absence.** Students should give notice if they cannot attend class. The absence notification will only be sent by text or email before class time.

The student will be responsible for the material covered in class during an absence.

1. It is **IMPERATIVE** to **be on time for class and rehearsals**. Students that consistently show up late for class without a reasonable excuse will be penalized with **a lowering of the final grade.**

2. **Concert and performance times are subject to sudden changes. Dress rehearsals will take longer than three (3) hours, and scheduling other activities on the same day as the dress rehearsal or performance is not recommended.**
3. **Failure to attend and participate in the semester's final concert, dress rehearsal, or any other public or private performance will result in a failing grade.**

Performance Dress Code:

1. It is an **absolute requirement** the use white pants or white skirts (ladies only, please) for the ensemble's concerts and performances.
2. A specific type of sports Jersey has been established as the official costume for performances. The student will cover the cost. An approximate estimate of the price is between \$25 -\$40. Details on cost and how to obtain the piece of attire will be provided by **week 4.**
3. No **sandals** for male performers will be allowed. Nice Sports shoes will be accepted. Dress Sandals will be accepted for female performers.
4. **Failure to comply with these requirements will result in removal from the concert program and a failed final grade.**

Rehearsal Room Use Policy:

1. All the ensemble members must organize the room into a class format after every rehearsal. Follow the organizational format posted at the door. **No one will be dismissed until the room is in order.**
2. **All ensemble members** will help store all the equipment in an organized manner inside the storage room and lock the door when finished. **The storage room door should always be closed when it is not used.**
3. After all, chores are done, please overview the room for any trash that can be collected and deposited in the garbage container on your way out.
4. The default status of room (Bain 101) doors is **“locked”** when they are not in use. **All Performance, Jazz Studies, or Music Ed Students must ensure that all doors are closed and locked** on the way out.

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on the total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is

recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

Graduates
