Course Description and Outline:

MUCM 3550-5550, sections 500/501 is an advanced placement performance course. Small groups explore a wide variety of styles. Groups are encouraged to research and perform repertoire from historic jazz groups and composers, and to become familiar with free jazz concepts, fusion, funk and blues styles. Groups may compose original music. Each group records and mixes their own project during spring semester. Students and/or groups participating for the first or second time receive more direction throughout the semester.

<u>Fall Semester:</u> Groups rehearse weekly and are required to perform during our Small Group Jazz Forum. Two performances are required, however; groups may perform outside of our Forum as often as they are able. One or more visiting guest artists spend several days on campus where they meet with each of our small groups for coaching sessions, and also perform in concert.

<u>Spring Semester:</u> In addition to their weekly rehearsals and required performances, each group will record and mix a CD project during our scheduled recording sessions. Selected groups are also featured on the UNT Showcase Stage at the Annual Denton Arts & Jazz Festival.

A <u>mandatory meeting</u> will be held in Kenton Hall at 4PM on our first class day. All necessary information regarding groups, rehearsal times, performances, and coaching schedules will be posted as soon as possible.

Course Goals:

To effectively guide students in the process of learning, understanding and becoming comfortable with the technical and emotional aspects of group performance, while further developing the confidence and ability to also speak musically as an individual. Additionally, learning to really listen to other performers enhances a musician's creativity. To that end, cell phones, computers and electronic devices will be turned off.

The ultimate goal is for students to expand and improve, and to experience the joy of playing, performing, improvising, listening, and effectively communicating with their fellow musicians and the listener.

Attendance Policy:

As a participant in this course, you are making a commitment to yourself, your group coaches, and fellow musicians. All students are expected to be prepared, and will be required to attend all of their scheduled group rehearsals, coaching sessions and performances. Additionally, students are required to attend each Forum when not rehearsing in a group coaching session.

- * Attendance will be taken by submitting your student ID into the Forum attendance box. Your absence will be recorded if you are not present when the TA removes the box and begins registering attendance.
- **'Excused absences'** are permitted with approval by the professor. Either the student or student's family must contact the professor via email, phone, or in person as follows:
 - * In the case of accident, illness or family emergency ~ within 48 hours after the absence.
 - * In the case of a known absence, permission may be granted one week or more prior to the absence.

Submitting the ID of an absent student is NOT permitted and will result in lowering the student's final grade by one letter. A second offense will result in an automatic 'F' in the course.

*Two unexcused absences will result in the lowering of your grade by one letter. Three will lower it another letter.

Four will result in a failing grade.
