## Course Objectives

This course is designed to immerse students in the jazz tradition while engaging with music and arrangements that are current and relevant. Throughout the semester, students will:

- Develop ensemble communication and performance skills within a jazz chamber music context.
- Explore the music of a specific jazz group or composer and prepare repertoire that reflects the style and contributions of that artist.
- Gain an understanding of arranging and performance practices that bridge traditional jazz with contemporary approaches.
- Focus on building a real band synergy

Tuesday rehearsals are coached, while Thursday rehearsals are uncoached.

## Attendance Policy

1. Attendance is mandatory for all rehearsals and performances.
2. If a student cannot attend a rehearsal, they must send a substitute of equivalent level or higher. Notice of absence and details about the substitute must be communicated to the professor at least 24 hours before the rehearsal.
3. More than 2 unexcused absences will result in a one-letter grade deduction per absence (i.e., an "A" becomes a "B," etc.).
4. An excused absence from a required performance or recording will result in the final grade being lowered by one letter.
5. An unexcused absence from any required performance or recording results in a failing grade for the course.

### **Financial Aid and Satisfactory Academic Progress**

#### Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

#### Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
