# **Course Philosophy and Goal**

By the end of this course, students will:

- Develop the ability to blend with other guitarists as a unified section, similar to a horn section in a big band.
- Strengthen ensemble skills by executing written lines with precision, balance, and stylistic awareness.
- Improve proficiency in reading, comping, and soloing across a variety of musical styles.
- Gain experience in arranging by creating one chart for guitar ensemble, including five guitar parts, one bass part, and one drum part. This arrangement may be based on a jazz standard or an original composition.
- Enhance listening, communication, and collaborative musicianship in a group setting.

# **Arrangement Submission Guidelines**

To have your arrangement featured in the final Syndicate show, you must submit your score at least two weeks prior to allow sufficient rehearsal time. It is recommended to start small and develop your chart step by step, progressing toward the final version.

- Submission Format:
- All digital submissions are due by Sunday night of the listed week.
- In some cases, you may also be required to bring a printed, taped and/or stapled copy to meet the submission requirements.

# **Timeline**

• Sun, Aug 31 (Week 2) – Format Drill

Submit a template score including all required parts (5 guitars, bass, drums) with correct formatting: fonts, indentation, measures per line, rhythm slashes, chord changes, etc. The score must be taped or stapled. Assignment details will be provided later in the semester.

- By this date, you should also choose your tune.
- Sun, Sept 7 (Week 3) Melody and Form

Submit a score demonstrating the melody and structure of your chosen arrangement.

• Sun, Sept 14 (Week 4) – Harmony and Soli

Submit a score with a harmonized melody and/or a soli section.

• Sun, Sept 21 (Week 5) – First Draft

Submit a rehearsal-ready score with all parts included. The score must be correctly taped or stapled for review and revision.

• Sun, Sept 28 (Week 6) – Final Draft

Submit your final draft for peer performance at the Syndicate on **Oct 14 (Week 9)**.

# **Policies and Grading**

**Grading**: Your grade will be made up of three separate components this semester

- 1) Attendance (33.3%)
- 2) Preparation (33.3%)
- 3) Arrangement (33.4%)

**Attendance:** In music and in life, your reputation is built on how you interact with others and how responsibly you meet your commitments. Professionalism begins here: being late or missing

rehearsals and assignments without notice not only disrupts the ensemble but also reflects poorly on your reliability.

When it comes to your arrangement work, remember that even a partial draft is better than nothing—it gives the instructor a chance to guide you and offer constructive feedback.

- Regular attendance is required.
- More than two unexcused absences may lower your final grade.
- If you must miss a class, you are expected to **notify the instructor in advance, find a sub, and take responsibility for catching up on missed material.**

## **Financial Aid and Satisfactory Academic Progress**

## **Undergraduates**

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is

recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

### **Graduates**

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
