Course Description

Introduction to collecting, wrangling, storing, managing, retrieving and processing datasets. Topics include fundamental concepts and techniques of data engineering, large-scale data harvesting, data wrangling methodologies, and storage and process architectures. Emphasizes applications and includes many hands-on projects.

Course Structure

This course is an 8-week online class covering one module per week.

Course Objectives

By the end of this course, students will be able to:

1. Develop an understanding of the fundamental concepts of modern data management, including data life cycle, data scaling, structuring data, and data lakes concepts.
2. Develop knowledge and skills in data harvesting, storing, retrieving, and processing using cloud technology.
3. Develop knowledge and skills in cleansing/wrangling data with Google Cloud Platform resources.
4. Develop a foundational understanding of data querying.

AI Tool Usage

AI is Permitted for Some Activities with Attribution:

The use of large language models and other generative AI technologies, including tools like ChatGPT, is allowed for specific activities or assignments designated by the instructor. Students must clearly indicate when AI-generated content has been used and cite the particular language model and platform used, following the citation guidelines of APA, MLA, or another relevant academic style. The majority of the work must still be the student's original creation. Violations of this policy will result in disciplinary action as outlined in the University's Academic Dishonesty Policy. Writing Assignments	Improve your originally produced writing using AI tools to edit, paraphrase, and proofread. Note if the percentage attributed to AI by the AI writing detector is scored over 20%, then the work will be reviewed further for a possible plagiarism violation.	Do not copy and paste entire works generated from AI tools. You may paraphrase or quote a small snippet, but you must cite the AI tool and use double quotations when using exact words from the AI tool.
Hands-on Assignments	Assist with understanding the assignment.	Do not copy and paste entire works generated from AI tools.
Exams	Use AI tools to prepare and study for an exam	Do not use AI tools during exams



Project & Presentation	Assist with understanding and guidance.	Do not use AI tools as your only source of information. Your references should come from a variety of sources, such as journal articles, conference proceedings, books, and other scholarly works. Do not copy the entire code or presentation from AI tools. AI tools like ChatGPT are better at generating pseudocode in programming languages (e.g., Python or R), but still require manual editing to ensure accuracy.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken online or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An online or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Transmission and Recording of Student Images in Electronically-Delivered Courses

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.

No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.

In case synchronous (live) sessions in this course will be recorded for students enrolled in this class section to refer to throughout the semester: Class recordings are the intellectual property of the university or instructor and are reserved for use only by students in this class and only for educational purposes.
