Course Description

Introduces project management principles and concepts, providing a foundation for managing data analytics projects effectively. Addresses project management knowledge areas, performance domains, roles and responsibilities of analytics teams, and agile practices to facilitate the production of industry-standard artifacts.

Course Structure

This course is a 16-week in-person class covering one module per week.

Course Objectives

By the end of this course, students will be able to:

1. Develop an understanding of the project management terms, knowledge areas, principles, performance domains, tools, processes, and techniques.
2. Differentiate between the leadership roles in business and analytics teams, including project manager, program manager, product manager, product owner, scrum master, data team lead, and other stakeholders.
3. Develop a project charter, plan, schedule, budget, task board, and lessons learned.
4. Demonstrate how to track and manage resources, issues, quality, risks, scope, decisions, and tasks.
5. Apply skills from project performance domains, knowledge areas, and agile practices to manage data analytics projects.
6. Develop and articulate project management deliverables/artifacts results and improve written and oral communication skills for face-to-face and online teams.



7. Develop the analytical and organizational skills required for project management challenges with data projects, and develop and execute workable action plans with an agile mindset.
8. Develop a working understanding of project success and failure factors and understand how these relate to the nature of data projects.
9. Gain preliminary knowledge for the different project management certification exams.
10. Apply skills and knowledge learned in class to real-world data projects and develop a mindset of providing value to the business.

If caught a second time, you will get a Zero for the course and will be reported to the Academic Integrity Office again. AI is Permitted for Some Activities with Attribution:

The use of large language models and other generative AI technologies, including tools like ChatGPT, is allowed for specific activities or assignments the instructor designates. Students must clearly indicate when AI-generated content has been used and cite the specific language model and platform employed, following the citation guidelines specified by APA, MLA, or another relevant academic style. The majority of the work must still be the original creation of the student. Violations of this policy will result in

Writing Assignments	Improve your originally produced writing using AI tools to edit, paraphrase, and proofread. Note if the percentage attributed to AI by the AI writing detector is scored over 20%, then the work will be reviewed further for a possible plagiarism violation.	Do not copy and paste entire works generated from AI tools. You may paraphrase or quote a small snippet, but you must cite the AI tool and use double quotations when using exact words from the AI tool.
Hands-on Assignments	Assist with understanding the assignment.	Do not copy and paste entire works generated from AI tools.
Exams	Use AI tools to prepare and study for an exam	Do not use AI tools during exams
Project & Presentation	Assist with understanding and guidance.	<p>Do not use AI tools as your only source of information. Your references should be from various sources, such as journal articles, conference proceedings, books, or other scholarly works.</p> <p>Do not copy the entire code or presentation from AI tools. AI tools like ChatGPT are better at generating pseudo code in programming languages (e.g., Python or R) but still require manual editing to ensure accuracy.</p>

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken online or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An online or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

UNT takes measures to protect the integrity of educational credentials awarded to students enrolled in distance education courses by verifying student identity, protecting student privacy, and notifying students of any special meeting times/locations or additional charges associated with student identity verification in distance education courses.

Use of Student Work

A student owns the copyright for all work (e.g. software, photographs, reports, presentations, and email postings) he or she creates within a class and the University is not entitled to use any student work without the student's permission unless all of the following criteria are met:

- The work is used only once.
- The work is not used in its entirety.
- Use of the work does not affect any potential profits from the work.
- The student is not identified.
- The work is identified as student work.

If the use of the work does not meet all of the above criteria, then the University office or department using the work must obtain the student's written permission.

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.



No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.

Class Recordings & Student Likenesses

In case synchronous (live) sessions in this course will be recorded for students enrolled in this class section to refer to throughout the semester: Class recordings are the intellectual property of the university or instructor and are reserved for use only by students in this class and only for educational purposes. Students may not post or otherwise share the recordings outside the class, or outside the Canvas Learning Management System, in any form. Failing to follow this restriction is a violation of the UNT Code of Student Conduct and could lead to disciplinary action.
