Course Description, Structure, and Objectives

Examines Agile frameworks and practices for analytics teams and projects. Facilitates the development of an Agile mindset and focuses on how to create business value through the values and principles of Agile.

This course is an 8-week online class covering one module per week.

By the end of this course, students will be able to:

1. Develop an understanding of the Agile terms, values, principles, and frameworks.
2. Develop and articulate agile artifacts and reporting results, and improve written and oral communication skills for face-to-face and online teams.
3. Demonstrate how to create and manage user stories on the product backlog and epics in the product roadmap.
4. Estimate story points with various techniques that use the Fibonacci sequence.
5. Apply skills from Agile values and principles to manage data analytics projects effectively.
6. Develop a working understanding and create a dashboard of Agile metrics.
7. Develop a roadmap to guide and prioritize Analytics projects and goals.
8. Gain preliminary knowledge of the different Agile framework certifications.
9. Apply skills and knowledge learned in class to real-world data analytics projects, demonstrating principles of an Agile mindset.

AI Tool Usage



AI is Permitted for Some Activities with Attribution:

The use of large language models and other generative AI technologies, including tools like ChatGPT, is allowed for specific activities or assignments designated by the instructor. Students must clearly indicate when AI-generated content has been used and cite the particular language model and platform used, following the citation guidelines of APA, MLA, or another relevant academic style. Writing Assignments	Improve your originally produced writing using AI tools to edit, paraphrase, and proofread. Note that if the percentage attributed to AI by the AI writing detector is scored over 20%, then the work will be reviewed further for a possible plagiarism violation.	Do not copy and paste entire works generated from AI tools. You may paraphrase or quote a small snippet, but you must cite the AI tool and use double quotations when using exact words from the AI tool.
Hands-on Assignments	Assist with understanding the assignment.	Do not copy and paste entire works generated from AI tools.
Exams	Use AI tools to prepare and study for an exam	Do not use AI tools during exams
Project & Presentation	Assist with understanding and guidance.	Do not use AI tools as your only source of information. Your references should come from a variety of sources, such as journal articles, conference proceedings, books, and other scholarly works. Do not copy the entire code or presentation from AI tools. AI tools like ChatGPT are better at generating pseudocode in programming languages (e.g., Python or R), but still require manual editing to ensure accuracy.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website \(http://www.ecfr.gov/\)](http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
