COURSE DESCRIPTION, STRUCTURE and COURSE OBJECTIVES

Study of themes related to contemporary French via recent movies. This is a three-credit course. The course will explore specific aspects of French society and culture and the discourse of humor as depicted in recent French

movies. It will focus specifically on major themes such as multiculturalism (stereotyping, communities, and racism), religion, family, social relations as seen through the prism of humor in French movies.

Other course objectives are to provide instruction and practice towards competence in French for advanced oral, written, listening and reading comprehension, with an emphasis on critical thinking skills through analysis of a range of themes.

***During the semester, we will watch several French films that introduce topics that may be provocative or controversial or may hold opposing views to yours. And at times, you may be uncomfortable with or not appreciate the way those topics are presented (e.g., presence of foul language, nudity, intimacy). Please remember to remain respectful when discussing topics with others. My goal is to conduct class in a way that fosters an atmosphere of mutual respect with room for different ideas or opinions.

This course is not approved for online curriculum delivery. The student and I will meet regularly. Time and date TBD between both parties.

COURSE PREREQUISITES

6 credit hours at advanced level or consent of instructor/department.

MEETINGS

Since regular oral practice is essential for improving proficiency in a foreign language, attendance and active participation are necessary for your success in this course. If you do not attend scheduled meetings and participate, do not expect to get credit.

ASSESSMENTS

Due dates and instructions will be in CANVAS. It is the student's responsibility to check due dates in CANVAS. Deadline for all "unit" assignments is set before exams. <u>There is no late work accepted</u>. All work turned in after the deadline will receive a grade of zero unless the student has a <u>university-excused absence (Links to an external site.)</u> and provides documentation with 48 hours of the missed deadline.

Presentation

Students will give two presentations during the semester. All the presentations will take place at dates indicated on the weekly agenda. General information, grading rubric, and topics will be posted in CANVAS.

Mid-semester and End of semester papers

Midterm Paper

Students will turn in a 2-3 pages paper in French (typed; double space – Font 12 - 1" margins) on a topic preapproved by instructor by instructor. Midterm paper due date is indicated on the weekly agenda.

Final paper

In lieu of a final exam, students will turn in a 4-6 pages paper in French (typed; double space – Font 12 - 1'' margins) on a pre-approved topic.

GRADE DISPUTES

- Your instructor will not discuss grades over email. If you would like to discuss a grade on a specific assignment or your overall grade, email your instructor to set up a meeting (either in-person or via ZOOM).
- You will need to have your video feed / camera on for any ZOOM one-on-one meeting with the instructor. You should come to the meeting with specific questions and /or examples that demonstrate why you should have earned a different grade than you received.
- If you miss your scheduled meeting, you forfeit your right to a grade dispute.
- If you do not contact your instructor to schedule a meeting within 5 (five) days of receiving your grade, you also forfeit your right to a grade dispute.
