Required Text & Materials: MyLab Math (MLM) is an online course delivery platform.

The textbook is Blitzer, Robert, *Thinking Mathematically*, 8th Edition, Pearson Publishers (2022). It is available online through MyLab.

Pearson MyLab Math, MLM: MLM is an online course delivery platform accessed directly through Canvas. MLM access includes all online homework assignments, the e-text of *Thinking Mathematically*, 8th Edition, by Robert Blitzer, and additional learning resources. Click on the MLM link in Canvas to register immediately. You must register in MLM by the 2nd class day of the semester.

MyLab grants a no-cost trial 14-day access if you have not previously used this option for this course. You must purchase your access before the temporary access expires. If you do not make the purchase before the trial period ends, you may lose credit for all work previously completed. Please use the same name you have in canvas when you register in MyLab. I cannot give credit to a student enrolled in this course for work completed under a different name.

Course Description: (3 hours) Topics include probability, statistics, algebra, logic, and the mathematics of finance. Additional topics are selected from geometry, sets, cryptography, fair division, voting theory, and graph theory. Emphasis on applications. Recreational and historical aspects of selected topics are also included.

The grade distributions will be 90% - 100% is an A, 80% - less than 90% is a B, 70% - less than 80% is a C, 60% - less than 70% is a D, less than 60% is an F. **There will be no curves.**

Video & Photography: You are not permitted to take pictures or record class. Any audio recording requires prior approval from the Office of Disability Access.

Calculator Policy: Calculators will be permitted for exams. A scientific calculator, like the TI-36x, is recommended. But a basic graphing calculator (TI-84 or equivalent) is acceptable. Calculators with CAS capabilities (e.g., TI-89, TI-92, TI NSpire) are not permitted. There are several free online calculators you can use while working on homework assignments as well (e.g., GeoGebra, Wolfram Alpha).

Attendance: Research has shown that students who attend class are more likely to be successful. Attendance is mandatory and students are expected to attend class meetings regularly. In this class, “attendance” means looking

alive and working through the examples in lecture as we go. Students are responsible for all information given in class, regardless of their attendance. If you miss class, you will be responsible for obtaining a copy of the notes and any other information discussed from a classmate.

Being punctual indicates respect for others. Please arrive before class begins to find a seat, prepare your materials, and connect with your peers. The beginning of class is especially critical, just like the beginning of a movie or book. Being late to class is sometimes inevitable. If you are late, you are welcome to join the class, but please do so without distracting others. Any tardiness, or leaving early, may be recorded as an absence from class.

On campus class meetings **are not recorded**. The instructor will not repeat whole lectures or offer personal lessons in office hours or email. These venues are for specific questions or problems.

Homework: Our MLM homework is found on the MLM website (link is provided on Canvas). NO LATE HOMEWORK will be accepted, regardless of reason.

The main purpose of homework is to provide you with opportunities to learn, practice, and retain new content. To that end, you will have two (2) – four (4) MLM online homework assignments per week, starting the first week of classes. Most MLM homework exercises have 3 attempts with some possible exceptions (e.g. multiple choice or true false questions).

Each week there will be homework on MLM for the sections covered that week. The homework will be due by 11:59 PM on Tuesday of the following week. For instance, in week 1 we will certainly cover module 1.1. Thus, the homework on this module will need to be completed by Tuesday night during week 2. This is to give ample time and flexibility should the unexpected happen, but ideally you should be completing the homework as you go through the module during the week. Keep in mind you will have to check MLM frequently to keep up with the due dates, there will not be reminders in Canvas. If the due times conflict with your schedule, WORK AHEAD. Since this class does not accept late work, to allow for the extremes circumstances that may affect your ability to meet homework due date, your lowest three (3) homework scores will be dropped.

Quizzes: The Study Plan Quizzes in MLM on their own will not be a part of the course grade, but you can earn up to 10 additional points per midterm exam. You have a timed Study Plan quiz in MLM for each content module. The quizzes are password protected and is “Start” (to make sure we don’t accidentally start the quiz). Use them as a part of your overall preparation for each exam. The Module Study Plan quizzes close at 11:59 PM the day before the exam. You have 5 complete attempts at each Quiz. These are not required but will be evaluated so that you can check your understanding; And you have the opportunity to earn extra points to your module exam as follows:

- Achieve at least 90%, earn 5 points.
- Achieve at least 80%, earn 4 points.
- Achieve at least 70%, earn 3 points.
- No points for scores below 70

You can also earn up to 10 additional points on the final exam. You have three comprehensive MLM Final Review homework assignments. Each review homework covers the entire course. They are required, graded assignments. These assignments must be completed before your final exam to earn bonus points on your final exam. The bonus points are as follows:

- Achieve at least 90% on one review homework assignment, earn 3 points.
- Achieve at least 90% on two review homework assignments, earn 6 points.
- Achieve at least 90% on all three review homework assignments, earn 10 points;

Late Submission Policy: All work must be submitted by the due date and late work will not be accepted for any reason. This includes online homework assignments as well as any written assignments, quizzes, and exams.

Exams: You will have three midterm exams and a comprehensive final exam all administered in person. There are no remote/online options for exams. Actual exams dates and content will be announced in class, usually at least two weeks before the actual exam date. The tentative exam dates are Sept. 18 (Modules 1 & 2), Oct. 21 (Modules 3 & 4), and Nov. 20 (Modules 5 & 6).

You may replace your lowest exam score with the final exam score if the latter is higher. If you miss an exam you will receive a zero for that exam, but you may use the final exam score for that exam. If you receive a zero for cheating on an exam, the final exam score will NOT replace that zero. Again, NO MAKE-UP EXAMS WILL BE GIVEN FOR ANY REASON.

Make-up / Early Exam Policy: No make-up exams will be given for any reason. An exam may be taken prior to the scheduled date. You must request for this accommodation via email at least one week prior to day you wish to take the early exam. If you miss an exam then a score of 0 will be recorded, and you may use the final exam score for that exam.

Disruptive Behavior: On any day, if you disrupt the class you will be asked to leave the classroom. You may also be reported for further disciplinary actions. Disruptive behaviors include – but are not limited to – talking, making inappropriate jokes, using phones in class, leaving class to answer phone, or performing other tasks that are not related to class work.

Course Structure: This is course meets in person on campus three (3) days per week, punctual attendance is expected. This means you are expected to physically attend each class period this semester. **There is no remote/online option.**

The course topics are structured into six content modules. The modules, in order, are Voting and Apportionment; Personal Finance; Problem Solving and Set Theory; Statistics; Probability; and Graph Theory.

Course Objectives: Upon completion of this course, the successful student will be able to:

- Solve problems involving voting and apportionment methods.
- Apply mathematical models to solve personal finance problems.
- Apply set theory concepts and skills to create Venn diagrams and effectively solve problems.
- Interpret and analyze representations of data.
- Solve problems involving fundamentals of probability and counting techniques.
- Apply graph theory principles to solve real-world application problems.

Exam Etiquette:

- Any student who arrives late for an exam will not receive extra time to complete their exam.
- Place all papers, textbooks, notes, etc., in a backpack or bag and close it securely.
- Turn off and remove all non-medically necessary electronic devices. This includes – but are not limited to – phones, earpieces, headsets, laptops, and smart watches.
- Handling of **ANY** unapproved electronic devices during an exam will be construed as cheating and will result in a zero for that exam. A notice will be filed with the Academic Integrity Office.

Federal Regulation

specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

If the use of the work does not meet all of the above criteria, then the University office or department using the work must obtain the student's written permission.

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.

No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.

Class Recordings & Student Likenesses

In case synchronous (live) sessions in this course will be recorded for students enrolled in this class section to refer to throughout the semester: Class recordings are the intellectual property of the university or instructor and are reserved for use only by students in this class and only for educational purposes. Students may not post or otherwise share the recordings outside the class, or outside the Canvas Learning Management System, in any form. Failing to follow this restriction is a violation of the UNT Code of Student Conduct and could lead to disciplinary action.
