## **Course Description:**

This course is designed to merge the basic principles and latest evidence-based knowledge and scientific understanding of sports nutrition with real-world practical applications and examples.

## **Course Objectives:**

This course is offered in a fully online format, which is very different than a traditional class. You will be expected to watch lectures and complete graded assignments in an online environment. Upon successful completion of this course, students will be able to:

- 1. Identify and describe basic macronutrients (i.e., carbohydrate, protein, and fat) and their respective sources.
- 2. Identify and describe the role of vitamins, minerals, electrolytes, and water in sport performance.
- 3. Demonstrate how to optimize one's nutrition to maximize sport performance.
- 4. Demonstrate knowledge on how to evaluate and modify one's dietary habits to improve sport performance.

## **Course Expectations:**

- 1. **Keeping up with course materials:** It is imperative that you stay on task and prepare for each class period in a timely manner. The course lectures are set to time release on specific dates, and you will be responsible for having viewed the lecture and completing the associated quizzes prior to the due date. This course is set up in 2 parts: [1] Modules 1-5 will be due by Dec 22 (Exam 1 by Dec 23) and Modules 6-10 will be due by Jan 13 (Exam 2 by Jan 14). You will be able to self-pace through this course, but these due dates are non-negotiable.
- 2. If you have special learning needs, please inform the instructor immediately.
- 3. If at any point during the semester you are unhappy with your performance in this class, please contact the instructor **immediately**.
- 4. **Academic dishonesty** will not be tolerated (i.e., copying, plagiarism, cheating) and will result in a failing grade for the semester.

## **Course Delivery**

The Canvas platform will be used to enhance the delivery of course materials and content. Students must check the Canvas site regularly for course updates and become familiar with their Canvas account. Canvas will provide students with important announcements, lecture notes and quizzes, assignment information, and other important materials necessary for successful completion of this course.

#### **Learning Modules:**

There are 10 learning modules in this course + syllabus module. Each learning module consists of two main components: [1] a recorded lecture and [2] a graded quiz. You will have until 11:59PM on the date listed on the calendar to complete the learning modules and quizzes.

#### **Learning Module Lectures**

Similar to a traditional classroom setting, you will need to watch lectures. The lectures are in voice narrated PowerPoint format, which has been converted to run on a standard web browser (i.e. FireFox, Chrome, Safari, etc.). You may watch the lecture as many times as you like. A printable "storyboard" version of the lecture is also available for download in PDF format in the same folder where you will find the online lecture. **You must watch the lecture in order to "open" the quiz associated with that module. The next learning module will not open until you have received a 60% or greater on the previous learning module quiz.** If you have access to the lecture but are having difficulties getting the lecture to play correctly, please contact the UNT IT helpdesk at 940-565-2324 or helpdesk@unt.edu.

## **Learning Module (LM) Quizzes:**

After you have watched the LM lecture for a given topic, you are required to take a quiz on Canvas to test your level of knowledge and understanding. In total, you will take 11 quizzes (1 syllabus quiz + 10 LM quizzes) worth 15 points each. You will be allowed an unlimited number of attempts to take each quiz and your grade will be reported as the 'highest' of your attempts. Each time you attempt the quiz you will be given a new random set of questions from the quiz question bank and you will not be provided the answers to the questions that you miss.

Thus, you may have to take the quiz several times in order to "unlock" the next module and/or achieve your desired score. In order to "unlock" new learning modules, you have to get at least 60% (9 out of 15 points) of the questions correct on the previous LM. Once you "unlock" a LM and its associated quiz, these will remain open for the remainder of the semester. In leaving the quizzes available all semester, you should be able to use these as a study tool to prepare for your exams. <a href="LMs 1-5 MUST BE completed by December 22">LMs 1-5 MUST BE completed by December 22 and LMs 6-10 MUST BE completed by January 13 in order for their respective exams to be open and completed on time.</a>

#### **Exams:**

Two non-cumulative exams will be administered via Canvas during this class. Exam 1 will cover learning modules 1-5 and Exam 2 will cover learning modules 6-10. Each exam is similar in format to the module quizzes and will consist of 50 questions worth 2 points per question (100 points per exam). The format and questions will be similar in style to the quizzes. However, **for both exams you will only be allowed 2 attempts** versus the unlimited number of attempts that are allowed during quizzes. **Your grade will be reported as the "highest" of your two attempts**. **If you fail to complete the exams by the respective due dates and times, NO makeup exams will be offered. This is non-negotiable.** 

## **Nutrition Analysis Assignment (DUE by DECEMBER 23 11:59PM)**

Based on the information you have learned in the first half of this course, you will be asked to assess your own dietary habits. You will be asked to record your eating habits for one week and then reflect on the strengths and weaknesses of those eating habits. You will not be graded on the quality of your diet. Instead, you will be scored on your ability to apply the information from the course to a real-life situation. You will be assessed on the thoroughness of your dietary record and application to nutritional guidelines. If you fail to complete the assignment by the due date you will be given a grade of zero (0), NO make-up will be offered.

## Research Article Summary (DUE by JANUARY 14 11:59PM)

This assignment is designed to help you: 1) learn how to search for and identify credible sources of evidence-based research and 2) critically evaluate and summarize nutrition research topics. You will first search for and select <u>one research article focusing on a nutrition topic of your choice</u> (e.g., supplements and sport performance, dietary and metabolic assessment in athletes, etc.). Searches will be conducted using PubMed or Google Scholar. Please note that the use of lay references consisting of but not limited to Google Searches, Magazines, Blog Posts, Wikipedia, etc. will not be counted as research articles. If you decide to use these as "sources" you will receive an automatic grade of zero (0) for this assignment.

You will then prepare a 2-page document that will be submitted into an assignment link found on Canvas as a Microsoft Word document. This document should include (1) the reference for the research paper you are evaluating, (2) a brief summary of the research findings, (3) a score for the article based on the Paper to Podium Matrix found in the Sports Science Exchange article (see Canvas) (4) a discussion on whether you think the findings from this research paper have potential to translate to applied work with athletes. Upon submitting your assignment, it will be checked for plagiarism and originality via Turn-it-in. If your submission comes back as a >20% match to previous publications, you will be assigned a grade of zero (0). Full credit will be given if all requirements are met while points will be deducted for missing requirements.

#### You will receive a zero if any of the following things are included in your submission:

- 1. Including non-research articles (e.g., Google searches, blogs, websites, magazine articles, books, etc.)
- 2. Not citing articles as "journal articles" in APA 6th format.
- 3. Copying text from one of your references (this will be noted on the Turn-it-in report)
- 4. Matching content >20% to other works (excluding the APA references)

If you fail to submit your assignment via Canvas by the due date you will receive a grade of zero (0) for the assignment. Late assignments will not be accepted for any reason. This is non-negotiable.

## **Academic Integrity Policy**

Academic Integrity Standards and Consequences.
