COURSE DESCRIPTION

This course provides a framework for creating new music/dance collaborative projects. It is an interdisciplinary, experiential exploration of collaboration between musicians/composers and dancers/choreographers, as well as an examination of music/dance collaboration from a historical perspective.

OBJECTIVES:

- Students will gain first-hand experience in the creation of collaborative music/dance works.
- Students will become familiar with a variety of approaches to collaboration between dancer/choreographers and musician/composers through historical exploration.
- Students will gain a deeper understanding of an art form other than their own.
- Students will begin to develop a common language to facilitate collaboration.
- Students will begin to understand the music/dance relationship and its effect on an audience's perception of a collaborative work.

COURSE FORMAT

This course blends lectures, discussions, and presentations with a strong emphasis on hands-on collaboration, all leading toward a final performance. The central focus is pairing composers with choreographers to create original works throughout the semester. These projects will be shaped by reading materials, videos, and class discussions on topics such as the collaborative process, the music–dance relationship, compositional techniques for dance and music, constructing a contract, and related issues. Experiential workshops form the heart of the class, providing dedicated time and space for collaborative exercises, assignments, and rehearsals with partners in preparation for the final show. Attendance at both the technical rehearsal and the final showing is required; if you cannot attend either, you must notify the instructor during the first week of the semester. The course culminates in the presentation of collaborative works at the Final Showings in UNT.

You will be required to study an extensive list of dance works covering a wide range of contemporary repertoire. The list includes works by international artists, women, and members of the LGBT community. Each topic is accompanied by an examination of dance and music examples by choreographers and composers, including Martha Graham, Doris Humphrey, Vaslav Nijinsky, Michel Fokine, George Balanchine, Merce Cunningham, Alexander Ekman, Wayne McGregor, David Ogle, Matthew Bourne, Lucinda Childs, Carolyn Brown, Marcia Haydée, Troy Schumacher, Kyle Abraham, Ohad Naharin, Shen Wei, Johann Sebastian Bach, Aaron Copland, Henry Cowell, Igor Stravinsky, Vangelis Papathanassiou, John Cage, David Lang, Mikael Karlsson, Ellis Ludwig-Leone, Donny Hathaway, Sam Cooke, BTS, and others.

FINANCIAL AID AND SATISFACTORY ACADEMIC PROGRESS

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

Graduates

Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eliqibility.
