Catalog Description:

Design, construction, and forming using basic techniques with an emphasis on sculptural forms and containers. Prerequisites: 2 of the following: ART 1600, ART 1700, ART 1800

Course Description:

An introductory course in jewelry making that explores the techniques, terminology, and processes of working with metal. Students will receive instruction on sawing, soldering, shaping metal, finishing metal, lost wax carving, investing, casting, and mechanisms.

Required Textbook: The Complete Metalsmith, any edition, Tim McCreight

Project Descriptions:

Project 1: Bezel Set Ring (140 points)

Design a ring that includes a bezel-set stone. The piece should be made of copper or silver and highlight one or more bezel-set stones as a prominent design feature. The finished ring should fit a predetermined finger discussed with instructor.

Project 2: Hinged Locket (140 points)

Design a three-dimensional hinged locket with pierced and sawed designs using 18g or 20g copper, brass, and/or silver.

The theme is: Memory. How do you hold a memory or feeling, something that seems physically uncontainable? We hold photos in albums and ideas in notebooks, but containing a memory is a unique challenge. Gifts can remind us of the giver, smells can remind us of a familiar place, and designs may carry great personal or cultural significance. Consider how you might store an intangible memory, emotion, etc. in a hinged locket.

Project 3: Cast Brooch (170 points)

Design a small brooch and carve it in wax, then cast it in bronze and solder on a pin back. Students must be present and on time for investing day and casting day. Theme: Self-Portrait: If you made an object that represented you, what would it look like? A flower you love, a geometric design that reflects your personality, an animal to which you relate? Consider how you might portray some part of yourself through a small cast brooch.

All samples, maquettes, and projects are due at the beginning of class.

The course schedule reflects expected class progress in course subject matter and is considered tentative. The course schedule is subject to change in content and scope. The instructor will provide verbal and written notice of all syllabus changes.

Class Participation Expectations:

I expect you to attend every class. You are responsible for completing all the required assignments. I expect all students to participate in class discussions, contributing ideas and perspectives on topics or art. All your work should incorporate aspects or issues addressed in class in relation to your personal or professional interests.

More than TWO absences will lower your final grade by half per additional absence (3 or more)

Most lectures, demonstrations, and assignments will occur at the beginning of class periods and will not be repeated for those who come in late. If you are late for class, you will need to notify me at the end of the class period to replace an absence with a tardy. Three tardies will constitute an unexcused absence.

A tardy is arrival 5 minutes after the beginning of class.

Critiques missed may not be made up and grades will reflect the student's failure to participate in the critique discussions. If the absence is excused, an alternate method for critique will be provided.

Please contact me if you are unable to attend class. It is important that you communicate with me *prior to being absent* so I may decide whether to accommodate your request to be excused from class.

Late Work Policy:

Late work will be subject to a penalty of 10% deducted from the assignment's value per day the work is late, unless the student provides proof of an acceptable mitigating circumstance: serious illness, death of a family member, or other circumstance if approved by the instructor.

Wear appropriate clothing - no loose sleeves, scarves or neck ties, no hanging jewelry.

No open-toed shoes, sandals or bare feet.

Keep long hair tied back.

Keep work benches clear of books, papers and clothing.

Do NOT leave torches lit when not in use.

Do NOT light torches with cigarette lighters.

Do NOT put hot metal objects into acid solutions.

All acid spills should be flushed with water immediately and neutralized with baking soda. Inform the instructor of any such spills.

Wear safety glasses or a face shield when using all machines.

DO NOT USE ANY MACHINE OR EQUIPMENT WITHOUT PRIOR INSTRUCTION. If it hasn't been demonstrated to you by the instructor, do not use it.

REPORT ANY ACCIDENTS, BROKEN TOOLS OR EQUIPMENT OR SAFETY INCIDENTS TO YOUR INSTRUCTOR AND/OR TECHNICIAN.

People who are not registered for a metalsmithing & jewelry class at UNT are not permitted to be in or use the studio facilities without express consent of the faculty. This includes children and the pets of students.
