## **Course Description**

This course introduces current issues in empirical finance with emphasis on the generation of research ideas and the development and testing of empirical hypotheses.

## **Prerequisites:**

Familiarity with basic econometrics and the use of statistical software. I recommend that you use SAS and/or Stata.

Permission of the FIREL PhD program director.

## **Course Objectives:**

To develop:

- Familiarity with current issues in empirical finance
- Analytical and problem-solving skills geared toward identifying potential research topics
- The ability to concisely present research ideas
- Empirical skills to facilitate the replication key results of empirical papers
- A fully developed research idea with preliminary results

#### **Course Requirements:**

- Access to a computer and both presentation (e.g., PowerPoint) and statistical software such as SAS and Stata for assignments.
- PowerPoint lecture modules or readings for each class session (links will be available on the course Canvas site).
- Regular reading of the business press, such as the *Wall Street Journal*, *New York Times*, *Financial Times*, or the *Economist* or specialized publications in specific topic areas such as *Bloomberg Green*.

## **Course Format**

The class consists of lectures and the presentation and discussion of assigned papers, proposed research ideas, and course assignments.

It is essential that you come to class *prepared to actively participate* in the discussions of the day's topic and be familiar with material from prior class sessions. The assigned readings for specific classes are likewise essential preparation as you will be called upon to participate in class discussion.

## **Assignments and Grading**

Most weeks will involve working on assignments, readings, and generating research ideas. Grades are based on participation in class discussions and presentation of assigned papers, as well as assignments including proposing research ideas, referee reports, and empirical assignments. While additional details will be discussed in class, a basic outline of the assignments is as follows:

## • Paper presentations

Every week you will present an assigned research paper. This entails preparing a PowerPoint deck with bullet point outlines of the following items:

- 1) Basic research question and key results
- 2) Motivation/Puzzle
- 3) Core idea / key variable of interest
- 4) Data
- 5) Empirical approach
- 6) What findings are interesting?
- 7) What is new / the contribution to the literature?

#### Additionally, you should discuss

8) The paper's strengths and weaknesses, and how the authors might address the weaknesses.

Be concise (a maximum of 15 slides in the deck for 15-20 minutes of presentation followed by 10-15 minutes of discussion/ Q&A).

PowerPoint decks must be emailed to me by 12 noon the Monday of our weekly class meeting.

## • Other assigned papers

You will also prepare a one-page bullet-point outline of the other research papers that have been assigned that includes the following items:

- 1) Basic Research Question
- 2) What is new / the contribution to the literature (as stated by the authors)
- 3) What are the paper's strengths and weaknesses?
- 4) Two questions/issues in the paper that you did not understand or would like clarity on.

Bullet point format of 2-3 sentences per item is sufficient.

Outlines must be emailed to me by 12 noon the Monday of our weekly class meeting.

## Participation

In addition to your designated paper, you are expected to raise comments and questions and comments about the other assigned papers during the class. The outline reports outlines are designed to help you with this.

## • Research pitches

Two ideas per week related to the topics we discuss in class.

One idea based on the academic finance literature – either related to a paper(s) that have been assigned in class or other finance papers that you have read.

One idea based on a business press article/industry report. This requires that you read ESG-related business articles on a regular basis.

For each idea you will prepare a maximum 1-page document outlining the following items:

- 1) Basic Research Question
- 2) Motivation
- 3) Core idea / key variable of interest
- 4) Data required (specifically what data/databases you would need)
- 5) Empirical approach (e.g., write down the specific analysis that you will use (i.e., the specific regression equation / empirical technique that you will use)
  - 6) What is interesting about the topic?
  - 7) What is new / contribution to the literature?

Bullet point format of 2-3 sentences per item is sufficient.

8) Include a link to the primary paper(s)/industry source in your submission.

Proposals must be emailed to me and your classmates by 12 noon the Monday of our weekly class meeting.

## • Empirical assignments

There will be several empirical assignments throughout the semester that will entail combining data from different sources, describing the data accumulation process, and ultimately producing a dataset as a basis for generating univariate and multivariate tables. For each assignment you will prepare a document that contains a brief outline of what you did and, as appropriate, tables of univariate and multivariate results. You must also turn in your code and data.

Reports for empirical assignments must be emailed to me by 12 noon the Monday before our weekly class meeting. Interim/final datasets and code will be uploaded to a shared drive at the same time.

#### • Research proposal

A capstone empirical project focusing on an empirical idea that you generate during the semester from one of your research pitches. You are required to submit a fully developed

proposal PowerPoint with preliminary results. The use of the MSCI ESG database is required for this assignment. You must also turn in your code and data. More details of the proposal will be discussed in class during the semester.

You will present the final PowerPoint pitch during the last class period. The final dataset and code will be uploaded to a shared drive at the same time.

## **Grading scale**

There will be a closed-book/closed notes final exam during the final exam period.
