Course Description

Spanish 2040 online is a language course designed to bring students to an intermediate level of proficiency in the Spanish language. The course focuses on Spanish grammar and emphasizes in particular listening, speaking, reading and writing skills. Students will participate in listening comprehension activities, oral projects, in-depth cultural study, readings, audio and video resources, as well as Web-based language interaction. The class will be conducted in Spanish and students are expected to use only Spanish in all assignments.

Course Structure

This is an intensive online course. The content of a regular semester course (16 weeks) will be covered in 3 weeks. All the content will be stored in modules in Canvas. Study assignments are organized <u>in 3 weekly modules</u>. Modules will cover **chapters 1-4** in the textbook and include specific information, guidelines and grading rubrics for each assignment.

Reading and Assignments

Information about weekly readings, pages to study, and assignments are stored in the **Course Assignments Schedule** (available in a separate document in Canvas). It is your responsibility to continually consult the class schedule and meet the due dates for all assignments. This is an **extremely fast-paced course**. To keep up with the workload, it is highly recommended to work on assignments every day. **Late work will not be accepted**.

Class Participation

The participation portion of your grade will depend on the level and quality of your interaction with other students and your professor in the course. As active participation, and to practice your writing, listening and speaking skills in Spanish, you will be required to complete <u>written and oral (video)</u> <u>weekly discussions</u> in Canvas on specific topics related to the chapter of study.

After you post your discussion, you will listen or read the posts of **two** students and you will give each of them a substantial comment (video or written). Full information and grading rubric are provided in Canvas.

Writing discussions and comments

Must be the student's work and should reflect their writing skills as proved in exams and quizzes. For

written discussions to be accepted, <u>the student must write the essay written portion of each exam</u>. Using translators or outside help for discussions will result in a grade of 0 without the opportunity to redo the work.

Video discussions and 2 comments

Written or audio comments will not be accepted for video discussions. Reading while making the video will result in a grade of 0 without the opportunity to redo the work. Full information is provided in Canvas. For more information and rules, read "Course Policies" section.

Early Discussions Submission to Earn Extra Points

Students who 1) submit their first post early (see the assignments schedule); 2) submit their 2 comments before or by the due date, and 3) comply with all the rules described below, will earn +3 points extra credit added to their discussion score for that week. The purpose of this incentive is to motivate early submission, and thereby provide a wider variety of posts for reply commenting by classmates.

Rules to receive the 3 extra points:

- a). Both comments must be substantial, include vocabulary and all the grammatical structures required in the discussion. Comments that do not meet with all the requirements stated in the grading rubric, will not receive the 3 extra points. For more information, read the rubric in Canvas.
- b). Students who submit their first post early, **but do NOT** submit their 2 reply comments **will not be eligible** for the bonus points because they did not fully complete the assignment.

Lockdown Browser System

Quiz 1 and all exams will be using LockDown Browser System. Instructions and the link to download the application in your computer is in "Where to get help" Module. To take the quiz and exams, you will need a webcam in your computer. If your computer does not have a webcam, you can take the exam in the Language Lab. Check their winter schedule or call in advance.

Quizzes

There is only one quiz in this course. It is an ungraded quiz that will help you to practice using "LockDown Browser" and recording your environment correctly. Taking this quiz is mandatory before taking exam 1. Before taking the quiz, you must read the folder "Rules and Regulations for Exams and Quizzes" in Canvas.

Take your quiz and exams as soon as possible. In case of computer problems, you will need time to solve them before the exam closes. If you experience technical problems, contact the UNT Help Desk for help, then contact your professor to report the incident. Make up for quizzes and exams will not be allowed due to computer problems.

Chapter exams and Final Exam

Exams will evaluate your listening, reading, writing, vocabulary and grammatical skills.

- There will be 2 chapter exams. Exam 1 will cover the grammar and vocabulary learned on your textbook in chapter 1. Exam 2 will evaluate the grammar and vocabulary learned on your textbook in chapter 2.
- Final exam will cover chapters 3-4.
- Your exams will be timed
- Once you start the exam, you cannot exit it without finishing it.
- Both exams exam will be using LockDown Browser System (if you did not download the application on your computer for quiz 1, go to the folder in Canvas and download it)
- Both exams will be open book. Take notes when you study, <u>you cannot</u> use another electronic device to access the book.
- You can use your notes, but you cannot take notes while taking the exam.
- You are allowed to have with you only the notes you took when you studied.
- Before taking the exam, remove from your desk any extra paper, all pencils, pens, and markers.
- Failure to follow the rules will result in a grade of 0 in the exam
- Exam study guides and important information is available in Canvas.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.

No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.
