#### **Course Objectives:**

Baroque Cello and Viola da Gamba lessons are weekly 30 minute or 60 minute meetings. Each lesson will consist of learning technique for the respective instruments as well as musicianship, history, and historical performance practice. The instructor will develop a plan and set goals that implement different exercises and pieces that can fill the necessities each student has in order to become proficient while playing their respective instrument. It is expected for the student to show up to their lessons on time with their instrument and music and having prepared for the lesson through individual practice. Some weeks will have assignments to assist with musical growth and knowledge.

#### **Course Goals and Assessment:**

Develop an understanding for the technique of the instrument as well as repertoire for the instrument. Demonstrate a good sense of musical articulation, phrasing, and expression. Students are measured by their individual improvement and based on each student's individual goals established by the instructor.

#### **Attendance Expectations:**

Students are required to attend the weekly lessons (either 30 min or 60 min depending on the credit hours). Failure to achieve this will be reflected in the final grade. Exceptions are made for prior notification to the instructor and include documented illness, university activities, emergencies, among other situations that may occur and are approved by the instructor.

#### Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

#### Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
